

# 10-10 Mobile Award and Mobile Worked all States

The Board of Directors, at the recent Tuscaloosa Board Meeting, approved two new 10-10 awards to be known as the 10-10 Mobile Award and the 10-10 Mobile Worked all States Award. The purpose of these awards is to recognize and encourage the use of mobile on 10 meters; and to collect as many different 10-10 numbers from mobiles as possible and to attempt to contact a 10-10 member in a mobile in each of the 50 states.

A mobile is considered any vehicle equipped with two-way radio capability for 10 meters, operated by a 10-10 member within the limits of the issued FCC license. Mobile would include auto, (including two and three wheel road vehicles), nautical and aeronautical. A mobile would be one operating from .....continued on page 5





power supplied by the vehicle and not tied to an outside power source or static antenna.

The Mobile Basic Award and upgrades are available to any full (dues paid-up) member of 10-10 who makes contact with other members who are operating mobile. The basic award level is 25 contacts with the following information: 10-10 number, call, name, location and date of contact. In order to prevent duplication, a copy of the applicants dupe sheet must be included with each application. In addition to a basic number, endorsements will be issued for submissions at the 50, 75 and 100 contact level. After the first 100 contacts, subsequent upgrades must be submitted in blocks of 100 contacts.

There are some exceptions to the rules - parking lot nets at conventions, swap meets or other gatherings are excluded as such contacts do not carry out the spirit and intent of the award. Mobiles enroute or departing from such events are, however, considered legitimate contacts if not included in the aforementioned net.

The second mobile award is the **Mobile WAS** (Worked all States) **Award**. This award will be available to any full member who works a mobile member in each of the 50 states. Submission must be accompanied by QSL cards indicating 10-10 number, location (state) of mobile, in addition to normal QSO information such as band (10 meters, or 28 MHz), date, etc. A single station may be used for only up to 5 states.

The start date for the Mobile Award and Mobile WAS Award is January 1, 1996. Watch for the announcement of availability of complete rules, work sheet, application and Award Manager. The Board believes that this should be a fun award and will create additional interest in 10 meter mobile activities and aid those 10-10 members looking for counties in which there is no ham population. Driving vacations will be fun next year when counties and states will be sought after for these new 10-10 awards.

#### Scholarship Fund Increased to Three \$1000.00 Scholarships Each Year



#### An-Ten-Ten-nas

In each issue of the *News*, we shall try to clarify a significant cluster of ideas used in antenna work. Our object is to help you make the best decisions about the antennas you buy or build



with out imposing our own prejudices on you. The more you understand, the better your choices will be.

#### No. 7 The Poor Old ZL Special

Because the ZL Special is such a mechanically simple and cheap antenna, it has spent its nearly half century of life misunderstood. Rightly understood, it has a place in the 10-10 inventory of antennas. It will not cure the blues on a rainy day or make DX in the absence of sunspots, but it may make a very useful attic or field antenna.

ZL3MH (later ZL2OQ and recently a silent key) brought the antenna to ham attention in 1949, giving credit to W5LHI and W0GZR for basic information on the design. G2BCX, who has developed variations on the design from the earliest days to the present, dubbed it the "ZL Special," and the name stuck.

The basic idea is deceptively simple: take a driven element and a slightly longer reflector and space them between a tenth and an eighth wavelength apart. Next, connect the elements with an eighth wavelength (adjusted for velocity factor of the line) with a half twist, and feed the former driven element with ladder line to an antenna tuner. The result is a 135° phased array. In the early 1950s when hams had difficulties building Yagis at home, the antenna seemed to outperform 3-element Yagis and give almost miraculous front-to-back ratios. The claims are almost embarrassing today.

First, the ZL Special, in any form, will have the gain of a 2-element Yagi at best. In fact, most decent designs show about 6.1 dBi forward gain in free space, about the same as the broadband Yagi described in the last column and about 4 dB better than a similar sized and placed dipole.

Second, the front-to-back ratio can range from great to mediocre depending upon design care, luck, and Murphy. Figure 1 shows two patterns of



the version we shall physically describe below.

They are taken over real medium earth at a height of 20' (for reasons we shall also note below). Casual building can achieve the broader pattern, while extensive design and experimental work might approach the "perfect" pattern.

The perfect pattern might not be more especially useful than the casual pattern, since it is so pinched. Any rear QRM just off center line will not feel the effects of the high front-to-back ratio, since it will fall within the off-center lobes. The casual pattern is only slightly worse than the lobes of the perfect pattern. Looking at the entire rear sector of an azimuth pattern is sometimes called analyzing the "front-to-rear" ratio.

The casual pattern is still useful for certain kinds of applications. It provides a better than 15 dB front-to-rear ratio across the entire backside. If the mechanical features of the antenna fit your building needs, then it may pay to try a ZL Special.

Most of ZL3MH's designs used unequal elements. A few years back, W7EL published a Field Day Special version of the antenna using equal length elements. Hence, I tend to call unequal element versions ZL Specials and equal element versions FD Specials. W7EL's antenna is made (like some predecessors) from 300-ohm good quality TV feedline. The general configuration appears in Fig. 2., scaled for 10-meter use.



The elements are folded dipoles 16'2" long. The 300-ohm phasing section is 4'3¼" long with a half twist between the front and rear elements. The phase line here is designed to be the same length as the distance between elements, thus producing a taut assembly.

You can feed the antenna in two basic ways. One way is to place capacitors in series with each feedpoint to compensate for some remaining inductive reactance at the feedpoint. Then a 1:1 choke balun links the feedpoint to regular coaxial cable. If finding the right amount of capacity to place at the feedpoint is a bit too much trouble, then feed the antenna with more 300-ohm ribbon brought to an antenna tuner. The feedpoint compensation will have no bearing on the basic properties of the antenna.

Heavy plastic squares with stress-relief slots and small machine screws as tie-point anchors should make easy work of the mechanical connections, front and rear. You can tape the antenna to bamboo and simulate a Yagi, but that is probably not the best use of the antenna. Better applications are as an attic antenna or an antenna strung between trees on Field Day and similar operations. A spacer bar at each end of the antenna and some rope ties will hold the antenna in place. These applications prompted the 20' height patterns, since they rarely permit very high antennas.

W7EL also noted a convenience: he attached half-wavelength sections of twin lead dangling from both the front and rear junctions. One just dangles (without touching the ground) while the other is connected either to the antenna tuner or the coax feedline. Swapping leads reverses the direction of the array. The dangling open-end half-wavelength line acts like a very high impedance, which affects antenna performance very little, if at all. Adjust these lines for the velocity factor of the ribbon cable, about .8 for most common 300-ohm twinlead.

Sounds simple, doesn't it? Mechanically, it is simple, but electronically, things get a little more complex. Some call the ZL Special a 135° phased array because they think of the rear element as 180° minus the 45° twisted phase line out of phase with the front element. This is true with respect to impedance values found at each element. However, it is current magnitude and phase which determine the performance of the array, and the target ballpark for that current is 315° (which is

also -45°) out of phase with the front element. The half twist of the phase line is equivalent to twisting the element itself 180° with respect to the front element, with an added 45° phase line between them.

Now let's make it a little more complicated: for any 2-element horizontal antenna, there is an optimum current magnitude and phase angle for the center of the rear element to give the maximum front-toback ratio. If the elements are about an eighthwavelength apart, the current magnitude is near the value on the front element and the current phase angle is nearly -45° relative to the front element. But, the antenna element lengths are also part of the overall geometry, and so the exact values for maximum front-to-back ratio are rarely these ideals. If you radically alter the geometry, like bending the elements toward each other at the ends, the natural values (or parasitic values, if you like to think in Yagi terms) change considerably from those found with straight elements at the same spacing.

Finding the exact dimensions for a perfectly phased ZL Special can be daunting and unrewarding, especially since the values also change with the antenna height above ground. (The "perfect" pattern in Fig. 1 required a modeled rear element current of 1.01 times the current on the forward element and a phase angle of -40.8° and those values differ from the free space model values.) ZL1LE has developed a "lumped constant" matching network that permits him to tune his antenna to the deepest rear nulls as he feeds both junction points with half-wavelength feedlines.

However, there is a big difference between a usable antenna and a perfect antenna. Most ZL Special designs will show little loss in gain and at least 15 dB front-to-back ratio up to 5% above or below the optimal current level and up to 8 or 10 degrees off optimal phasing. Hence, even casual ZL Special designs get the job done, even if they are not perfect. That is why most antenna analysts (who are usually perfectionists) tend to hate the ZL Special, while many a poverty-level or teenage ham has learned to love the antenna.

Like the hams of the 50s, I prefer to use an antenna tuner with the ZL Special because I do not have to recompensate the feedpoint every time I move the antenna. And tuning one up to acceptable performance is a matter of adjusting the length of the phasing line, usually making it longer and a bit more saggy than most of the magazine designs show. Twin lead is cheap

## TenX DX NEWS

As I write this, the Convention is just a few more days away and the band has been open for one and two hop short skip in the US. I have been working new counties to makeup for the DX that I can not find! I just worked three new Wisconsin counties so this is a good time to find new counties and pick up a few certificates during the summer months.

Conditions have been poor for DX as we continue to slide to the bottom of Solar cycle 22. The only DX worked has been during openings into the Caribbean, Central and South America. I have not heard Europe or Asia since February and I last worked Africa in March. Solar conditions will begin to improve when we enter the next Solar cycle which is at least a year off. Keep looking for the short skip and fill in your operating needs with 10-10 numbers, VP numbers, certificates and counties, as band conditions allow.

The biggest DX news this Summer was the first ever amateur radio operation from P5 North Korea by a group of Finish business men selling Telecom equipment to N.Korea. Most of the radio activity was on twenty meters and DU9RG Robin #36943, was one of about twenty lucky stations to work OH5AM/P5 on 14.295. This was a demonstration for the North Korean officials which lasted for 1-1/2 hours on May 15 at about 1420Z.

There was some activity from P5DPRK on 40 CW reported and a complete station was donated to an educational institute in N.Korea. Look for P5 to be voted by the ARRL as the next DXCC country now that an authorized amateur operation has been recognized and amateur radio contacts have been made. I expect more Dxpeditions will emerge from P5 just like China did several years ago, just be patient! Now, if we could just hear them on ten, that would be great news! Thanks to OH2BH Marty Lane (non member) and his Finish group.

I received two new 10-10 QSL cards during the past months! I worked V51C Namibia by Ian #32960 (ex ZS9IS) and YA5MM Afghanistan by Nodir UJ8JMM #52767. QSL Ian Sutherland, Box

2327, Walvis Bay, Namibia, Africa. QSL for YA5MM: LA1HA Ted Dikov, POBox 32, 1000 Sofia, Bulgaria. Include \$ for postage.

The count of 10-10 Countries is at least 272 now that activity from YA, Afghanistan, has been confirmed! I continue my research for any DX that may have been active from countries that are not on my DXCC 10-10 worked list. I would like anyone's DX worked list to update the DXCC list. My DXCC list is available for an SASE and 2 stamps.

#### Feature DX Station:

WP4MSC Puerto Rico by Jose #67225 was worked in April & May. Jose has a new 10-10 number and is very active when the band is open. When I first worked him, he had already worked about one hundred members so he has been very committed to his 10-10 number collecting. Jose lives on the west coast of Puerto Rico in the city of Mayaguez. Jose operates his station with a Yaesu FT747 feeding either a vertical, a Antron 99 Solarcov, up 25 feet or a three element beam up 12 feet. (I hope he gets his beam up higher to help his signall) NP4QH Monserrate #63541 helped Jose get his number. The second time we worked, Jose was having a problem with his microphone. The third time we worked, he had fixed his microphone and was calling CQ 10-10 with many takers as the band was wide open. I sent him a QSL card back in February when he was collecting numbers to join 10-10. Jose waited until his QSL cards were printed, with his 10-10 number in large numbers, before he sent his QSL to me recently. He told me that he tries to work 10-10 daily but for many days there has been no propagation to Puerto Rico. QSL to Jose Moreno, ...continued on page 11

Duliebra 79, Mayoguez, Puerto Rico 00680. Include US postage.

BS7H Scarborough Reef by KJ4VH Tim #41856 put on a DXpedition with five other operators from what could be another new country if the ARRL votes for approval! This Island is off the coast of China (BS7) in the South China Sea. This latest operation in April made about 12,000 contacts but I have no reports of any 10-10 activity. Expect more in 1996.

Propagation: Solar flux will range from 66-92 in the Summer/Fall 1995 which will be very close to the lowest flux levels of the previous Solar cycle 21. As I write this, the Solar flux is 69, the A index 9 and K index 3, down from a flux high on May 18 of 95, A = 25 and K = 2 which was just a few days ago. Expect flux dips to 61, high A indexes greater than 20 and the K index greater than 5. will occur 30% of the time. For stations in the US, expect a 5% chance of DX propagation to be East-West paths into Europe, Asia and Africa. For stations in S. America, expect a 35% chance of DX skip into Europe and Asia. Expect sporadic E Layer conditions to be one & two hop skip from 400 to 1600 miles with fading, when there is no DX skip. This could last 12-24 months until Solar cycle 23 begins. Remember to listen for the beacons (28.2-28.3) when you want to check band conditions. I read an article by one of my favorite propagation people, KH6BZF Lee #8888, who is predicting August 1997 as the start of the next Solar cycle. The NOAA agency has predicted May of 1996 as the start of Solar cycle 23.

NEW CALL SIGNS: The FCC will begin assigning AL, KL, NL and WL prefixes followed by ANY number from 0 thru 9 for Alaskan amateurs. There will be an exception for call from US Personnel in Korea (KL9KAA thru KL9KHZ). Hawaii: AH7, KH7, NH7 and WH7 will be used for Hawaii. The same prefixes with a 'K' following the number will be assigned to Kure Isl. Caribbean: KP3, NP3 and WP3 (or 4) will indicate Puerto Rico except Desecheo Isl.

Fiji 3D2LF by AA6LF Steve #50995 began operating in late May for two weeks from IOTA OC-156 and OC-121. Steve is in the middle of a seven year circumnavigation and DXpedition and is planning many stops from his sailboat before spending next winter in Australia. QSL to AA6BB.

9X/ON4WW Rwanda by Mark #49103 has been active thru June using an FT900 and R7 Vertical

mainly on CW. I found reports of Mark on 160 thru 15 meters but nothing on 10 as yet. This would be the first reported 10-10 activity from Rwanda if he gives out his number! QSL to ON5NT.

**Upcoming Dxpeditions:** 


CY9 St. Paul Isl. by AA4VK Ron #12423, W5IJU Vance #63352 and two other non member ops will set up on the island July 27 to August 2. All modes including satellite. All permissions have been obtained plus the boat charter. They plan to use big yagi antennas so lets hope the propagation gods allow us to hear them on ten as this will be a new 10-10 DXCC country!

Vietnam 3W by a group of seven operators are planning to travel to Vietnam in January of 1996. The main mode of operation will be CW but expect SSB activity on 40 - 10 plus WARC. No callsign has been issued as of yet. As with previous operations, the government will likely assign fixed frequencies and these will be published in advance. Look for N7WTU #21616, AA7NO #11404, WA7LNW #23594.

VKO Heard Isl. by a select group of ops are being organized by WA4JQS Tony #3621 for a DXpedition to this rare island around the end of 1996. This will coincide with the 50th anniversary of the establishment of the Australian base on Heard Island. Tony is currently attempting to replace the equipment lost on the Peter I DXpedition which cost \$20000.

1YRL Italy by Luc #58966 will be active from 4U1ITU in May & September 95 and from 3A (Monaco) in June & September 95. QSL to Glarey Luc, Via S. Martino 11, 10091 Alpignano, Torino, Italy.

#### **Board Meeting Minutes Report**

Note: The following is a report of the minutes of the Board of Directors Meeting published in accordance with the Board directive as noted in Item 15-5 below. It is a summary of the actions taken by the Board. A copy of the full minutes is available to any full member as noted in Item 15-5 below.

The Board of Directors of 10-10 International Net, Inc. convened at 8 A.M., June 16, 1995, at the Capstone Sheraton Inn, in Tuscaloosa, Alabama. Present were President Tom Henderson, K4CIH, Vice President Chuck Imsande, W6YLJ, Secretary David Prichard, KA5OVO, and Directors Linda Bames, KJ4FM, L. B. Cebik, W4RNL, Jack Miller, W9WYN, Joe Williams, WA9TSG, Ed Redwine, K5ERJ, Marv Hagan, WB2SJQ, Pete Matson, KC1CP, Bill Howe, VK4WBH, John Ellison, W0ERZ, and Norm Lefcourt, W6IRT, past President. Also present as a non-voting member was Treasurer Keith Schlottman, K17RK. The Board observed a moment of silence in memory of our silent keys. The agenda and orders of the day were approved, and the minutes of the July, 1994, meeting of the Board were approved.

The President presented his report to the Board, announcing Benny Wooten, KE4SDU, as chairman of the nominating committee for the next election. The meeting was then turned over to the Vice President for his report. VP Imsande also gave his report as Editor of the 10-10 NEWS, chairman of the PR committee, and the reports from Historian and Scholarship Manager, Morrie Goldman, W6EHM. President Henderson moved to ask Morrie Goldman, W6EHM, to chair the Life Membership committee. Motion was sec-

onded and passed.

The Secretary gave his report, noting his postage and phone costs were much less since signing on to E-Mail. After much discussion and a comparison of costs, the orders of the day were suspended and Director Cebik moved that the board members be reimbursed, at a maximum of \$9.95 per month, effective June 1, 1995, for their expense for E-mail. Motion was seconded and

passed.

Treasurer Keith Schlottman next reported he has designed new forms for expense reports and the need for all board members to turn in receipts for expenses by the 10th of the month. President Henderson moved and was seconded to except the new forms, as modified and motion passed. Treasurer Schlottman made his well documented financial report, stating we are financially sound at this time with reserves to cover future expenses from life memberships. Director Hagan moved and was seconded that the financial report be excepted, motion passed.

The Board adjourned for lunch at 11:30 A.M. and recon-

vened at 1:00 P.M., with all members present.

Director Barnes offered the annual report of the Communications Committee, reporting on the appointment of Joyce Medlen, KE4KGB, as the Chapter Coordinator/Awards Guide Editor, after the election of David Prichard, KA5OVO, as Secretary of 10-10. The work to create more exposure for 10-10 at various ham functions was also discussed. Director Barnes also proposed a set of operating guidelines for the Communications Committee to be included in the Operations Manual. VP Imsande reported he has prepared a slide presentation about 10-10 for showing at ham functions. Motion was made by Director Matson and seconded that the operating guidelines be accepted for inclusion in the Operations Manual, motion passed.

V.P. Imsande read the report of the Finance Committee stating they had been working on the possibility of allowing members to use Visa and Mastercard to pay for membership dues. VP Imsande recommended that 10-10 accept the offer from LinGer to

be our credit card service, for dues, at the regular yearly price only, for a rate of 5% of the total transaction.

Director Williams read the report of the Membership Committee and presented the Board with the Operating Guide for the various managers. Director Williams also discussed the need for help with for our DX members that don't have the ability to obtain U.S. dollars to pay their dues. Our DX manager, Carol Hugentober, KBDHK, has agreed to oversee a program that allows for members to "adopt" DX members with this problem.

Director Redwine presented the report of the Operations Committee. Director Redwine explained the appointment of Allen Mattis, N5AFV, as 1000+ Bar Award Manager, and Carl Fisher, W0HIK, as VP Bar Awards Manager. Director Redwine reports the Committee now recommends the full ratification of the appointments by the Board. President Henderson moved, and was seconded, that the Board accept the two award manager appointments. Motion passed. Director Redwine also reported on the various activities of the committee.

Director Ellison presented the report of the Planning Committee, stating that Director Miller had done an excellent job planning the agenda and orders of the day for the Board meeting. Directors Ellison and Miller both state the need to find a 10-10 chapter that would sponsor the next 10-10 convention in 1997, and the need to select the location of the 1996 Board meeting.

Gerry Gross, WA6POZ, presented his report as Data Manager. Gerry presented a detailed report on all of his duties, including the changes made in the data base, the printing and mailing

of the 10-10 NEWS, and the total membership count.

Under the Orders of the Day,

Item 15-1, on the proposed amendment to the bylaws by President Henderson, Article XII, Amendments, Clarification of Who may petition, delete the 1st sentence, and insert the following: "Petitions to change the bylaws may be submitted by the membership, to the Secretary upon signatures of at least 20 current, (dues paid), members." Amendment passed.

Item 15-2, bylaws amendment by Director Cebik, Article IX, Section 9, Election procedure, delete present text and insert the following: \*Officers and Directors' terms of office shall commence on the 1st day of October immediately following their elections\*.

Amendment failed.

Item 15-3, bylaws amendment by Director Matson, Article V, Section 3-A, Government, delete present text and insert the following: "The board of Directors shall consist of, the President, Vice President, Secretary, and no more than 10 Directors. Each member of the board shall, without exception, have one vote, with no proxy votes permitted, to go into effect on 1/1/97\*. Amendment passed. Article V, Section 3-B, Addition, "No one shall hold more than one position at a time on the board of Directors." Addition passed.

Item 15-4, bylaws amendment by Director Matson, Article VI, Section 3, delete the words \* Except the immediate Past president\*, and insert the following, \*Each Officer and Director shall serve a term of four (4) years or until his or her successor is duly elected and installed in office.\* Amendment passed and will go into effect as of 1/1/97. Article VI, section 6, add the third sentence, \*Changes in the bylaws shall only be made in the presence of the board of Directors, and shall not be made by mail or phone\*. Amendment passed.

Item 15-5, Operations Manual changes by Director Cebik, section 3.3.2.2, Board meeting minutes reporting in 10-10 NEWS. Revision of this section to read: "Immediately following a regular meeting of the board of Directors, the Secretary shall provide a report of the meeting of the Board to the Editor of the 10-10 NEWS for publication in the next quarterly issue for the information of the members. It is understood that this report is based on minutes not yet reviewed and approved by the board of Directors. The report shall begin with a detailed report on actions affecting the full membership, continue with a report of hanges to the bylaws, (omitting

voting and discussion details), in accord with Article XII, Section 3 of the bylaws, and conclude with a listing of other actions of the Board that affect only the board or other, (Volunteer), net officials. The Information Manager shall make copies of the full minutes available to interested members who send him or her an SASE for that purpose, Motion to accept the changes passed.

Item 15-6, Operations Manual changes by Director Matson, Section 3.1.6, addition to Office of the President duties, add to the first sentence after 10-10 Operations, 'and assign additional

duties". Motion to accept change passed.

Item 15-7, Operations Manual new section by Director Matson, delete the listing of any members holding positions in 10-10 from any sections, and add an appendix, (new Section 15), with the listings. Motion to accept this addition passed.

Item 15-8, Operations Manual addition by Director Redwine, Section 4.4.1, addition to Operations Committee procedural guidelines, motion to accept these additions as changed, passed.

Item 15-9, New 10-10 Mobil Award and W.A.S. program by Director Redwine, section 4.4.1, of the Operations Manual, the committee proposes new awards for 10-10 Mobil Operation, with Dave Becker, K7PRZ, as awards Manager. Motion to accept this new award is passed.

Item 15-10, Lifetime membership time payment plan by Director Ryan, the motion was proposed to allow members the option to pay for life memberships on a payment plan, motion passed.

Item 15-11, DX membership dues, in order to help the DX and stateside members pay their dues, Past President Lefcourt made a motion, seconded by Secretary Prichard, that 10-10 accept credit card payment, (Visa and Master Charge), for dues, with Lin-Ger as credit card service, at the rate of 5%, per card charge. Motion passed.

Item 16, consideration of 1996 Board meeting sites, Director Miller proposed the Chicago area, President Henderson moved to make Director Miller chairman of the 1996 Board meeting site chairman, motion was seconded, motion passed.

Item 17, consideration of 1997 Convention site, the Planning Committee will be in contact with several 10-10 Chapters, in search for a Chapter that would sponsor the 1997 10-10 Convention.

Item 18, Unfinished business, there was none.

Item 19, New business, we had a request from Don Zielinski, KOPVI, for consideration by the Board, for assistance in financing a larger building for the Big Horn Museum of Amateur Radio. Charter memberships are offered for \$500.00 donations. President Henderson made the motion that 10-10 donate \$500.00 to this undertaking with the provisions that all 10-10 members and their families be given free admission for life. Director Cebik admended the motion to add, and the Museum show proof of nonprofit status from the state. VP imsande moved the motion be tabled until the time 10-10 receives proof of nonprofit status and a provision be made for someone to assume the responsibility of the Museum in the event Mr. Zielinski is no longer able to do so. Motion to table the original motion carried.

Director Cebik moved and was seconded, that the office of Records Manager be removed. Motion passed.

V.P. Imsande proposed that 10-10 prepare, publish, and sell, a OM/YL Rooster. Motion to do so was made by Past President Lefcourt, seconded by Director Matson, and motion passed.

V.P. Imsande informed the Board that the contract with LinGer has expired. Director Matson moved that 10-10 accept the new contract with LinGer, motion was seconded by Director Howe, and motion passed.

A motion was made by Director Williams, to extend the three years dues for \$25.00 special until the 1997 Board meeting.

Motion was seconded by Director Ryan, motion passed.

Director Cebik moved to add new subsections to section 7.3. of the Operations Manual, to read, "Chapter may publish for their members, newsletters and similar publications. Because Chapter newsletters reflect upon the entire 10-10 organization, such publications should promote the goals of 10-10, and the goals of 10-10 Chapters in a positive manner, for example, promoting the use of 10 meters, assisting radio amateurs in their technical skills, and good operating practices", to become section 7.3.2, and as section 7.3.3, "Flagrant failure to live up to the guidelines above shall be grounds for termination of Chapter affiliation with 10-10." Motion was seconded by Director Hagan, motion passed.

Motion was made by V.P. Imsande, that call areas managers, volunteer or otherwise, follow all rules as set out by the membership committee. Motion was seconded by Past President

Lefcourt, motion passed.

Motion was made by Director Barnes, that the procedural guidelines, as proposed by the Communications Committee, for the Communications Committee, be incorporated in the Operations Manual. Motion was seconded by Director Redwine, motion passed.

A proposal and motion was made by Director Matson that 10-10 have a business card printed stating, "10-10 members can often be found on 28.345 or 28.825.", to be passed out at various arnateur radio functions, and distributed to amateurs that show an interest in 10-10. Motion was seconded by Director Miller, motion passed.

Motion was made by President Henderson, that the positions of Awards Guide Editor and Chapter Coordinator, be separated, with the Awards Guide Editor coming under the control of the Communications Committee, and the Chapter Coordinator under the Operations Committee. Motion was seconded by Past President Lefcourt, motion passed.

Item 21, article XIII, motion was made by Past President Lefcourt that the effective date these revised bylaws, adopted by the Board of Directors, be June, 16, 1995. Motion was seconded by Secretary Prichard, motion passed.

There being no turther business before the Board, the Board adjourned sine die at 5:10 P.M. to prepare for the 10-10 bandulat

quet,

At a special call meeting Saturday afternoon, June 17, 1995, the motion was made by V.P. Imsande to change the number of scholarships that 10-10 awards each year, from two (2), \$750.00 scholarships, to three (3) \$1000.00 scholarships per year. Motion was seconded by Past President Lefcourt, motion passed.

Motion was made by President Henderson to except the proposed budget as amended (to include the change in scholarships). Motion was seconded by Director Ryan, motion passed.

Motion was made by V.P. Imsande to adjourn. Motion was seconded by Director Hagan, motion passed.

#### 10-10 Member Looses Antenna Appeal


David, WA4NST and Sharon Brower, N4XLF #55141, of Vero Brach, FL have lost their appeal to have an external antenna at their residence. It seems a neighbor does not like the way it looks and the Brower's transmissions interfere with their electronic devices. This legal preceding began four years ago.

On January 15, 1993, Judge Charles E. Smith of the 19th Judicial Circuit Court ruled that "...amateur radio transmissions are noxious and offensive" and the appearance of a tower and antenna are "...an eyesore annoyance and nuisance to the neighborhood" and as such violates the deed restrictions.


He further said the tower was a "building" which exceeded the two story limit in the deed restrictions and, must be removed. According to the Browers, the deed restrictions in their subdivision are silent about external antennas. An appeal was filed and their tower was allowed to remain pending outcome of the appeal. But the Browers have been unable to operate for nearly two years during the appeal process.

A panel of three judges from the 4th District of Appeals has now agreed that the tower indeed is a nulsance and annoyance and must be removed. The only alternative left for the Browers is to sue in Federal court. The cost for this would be about \$20,000 and they have appealed to the ARRL to continue their legal battle. They maintain "The successful outcome will ultimately benefit all US amateurs.

10-10 is looking into an IOTA Award for the future and it should be an interesting challenge to work 10-10 stations on islands around the world.



#### Amateur Radio Enhances the Children's Museum in Wichita, Kansas

For the past eight years, the Wichita Amateur Radio Club has operated their club station, W0SOE, #41667, at the Wichita Children's Museum. The station was first initiated by Sharon and John Minor who's calls are KD0XW #41647 and WD0EDK #33052. John and Sharon turned the station operation over to Roger N. Wilson, KD0AY, who was its coordinator for several years. The stations present coordinators are Bill Turner, N0GGO #41649 and Curtis Boughton, N0UGJ.

The station's equipment includes a Kenwood TS44S and a Santec 2 meter transceiver. There is also a packet station in operation. Antennas include a Mosely 3 element tribander for 10, 15, and 20 meters. Stacked on top is a 3 element Cushcraft A3WS which operates on 12 and 17 meters. Also used are a Butternut HF6VX vertical and a Ringo Ranger for 2 meters.

The museum's station is operated every Saturday afternoon from 1:00 p.m. to 3:00 p.m. CST. A rotation of nine sets of operators is used to operate the station. It's purpose is to acquaint both children and adults who come into the museum station with amateur radio, and the excitement of communica-

tion with the people of the United States and around the world. Outside speakers pipe the radio conversations out into the museum.

#### 10-10 Reflections

10-10 Historian



Thirty-three years ago, the first organizational meeting of the 10-10 Net convened. Here are the minutes of this meeting:

"The first meeting of the 10-10 Net was held on Sunday, April 29, 1962, at San Dimas Canyon Park, California. Temporary Chairman Irv K6PWO (SK) called the meeting to order at 1430 hours PDT. The first order of business was the unanimous election of Irv, K6PWO (SK) as President and Joann, WA6QKC as Secretary-Treasurer.

It was moved by Win, WA6CBJ that the official name of the net be, "10/10 Net, Los Angeles Area." Motion seconded and passed.

Discussion was held on the requirements for the proposed net certificate. a final motion was made that a minimum of ten contacts with members of the 10/10 Net on ten meters should be qualification for awarding the certificate. Final motion was passed.

A motion was made, seconded and passed that DX be invited to check into the Net and discussion was held on the means for doing this.

It was noted that the first official QSO on the 10/10 Net was held Feb. 9, 1962.

Respectfully submitted, (signed) Joann McDonnel, WA6QKC, Secretary."

Note: 10-10 numbers were subsequently assigned to Irv, A6QKC #14 and Win, WA6CBJ #110.

Twenty years ago, the results of the 10-10 Net K6PWO (SK) #97, Joann Contest of February 8-9, 1975 were published in the July 1975, Bulletin. No. 1 was W5YZL #8333 469/1308; No. 2 was K6SVL #9555 509/1269; and DX No. 1 was LU7FAG #196 234/671. The Nutmeg, Connecticut-Massachusetts, was the highest scoring chapter, 2972/6638. Contest Manager Grace Dunlap, K5MRU #218, reported 329 logs received,


compared to 187 the previous year (February 1974).

Awards Manager Frank Orcutt, W4JO (SK) #386, reported in the July 1975 Bulletin that the Awards Program was initiated in 1965. Over 800 members have participated and we have issued more than 2750 Bar Awards to date. The 2500 Plaque is the top award for 2500-plus contacts with member stations. K5MRU #218 is No. 1; WØRWC (SK) #581 is No. 2; W8NQR #1243 is No. 3; and WA5JDU #3017 is No. 4. Contacts through Oscar-7—launched November 16, 1974 with the call W30HI and issued the 10-10 number 10,000—are still going strong. Many have reported Two through Ten contacts to acquire their No. 10,000.




less in pursuing correct records.


