Had a blast in San Antonio at the board meeting. Once we found the place, anyway. Thank goodness for cellular telephones! We called the hotel and had them direct us right in. Could not believe the River Walk and all the restaurants and shops. Was a great place to take a morning walk too. The Alamo was right next door. Lots of history there. My xyl Sandy and I took a horse and carriage ride around town. Was a lot of fun....but there was a lot of business done too!

The board meeting was very productive. Some of the things discussed were the approval of eQSL's for 10-10 awards requiring QSL confirmation. Another was the approval of the 2003 Convention site - which will also be in San Antonio at the Omni (which I am told is a very nice place).

Something else done was adding Digital modes to the CW contests - yes that means PSK is now a valid mode for contacts. Just remember that you can only count one contact with any callsign during a contest - regardless of mode. This should give the CW contests a little more activity as there are usually not that many CW logs submitted compared to phone contests.. Read page 26 - section 6.2.10 QSO Party Rules subsection 1. It has been highlighted for your convenience.

Also for contests - I have developed a new program to score the 10-10 QSO Parties. The board is allowing me to test it out for the next three contests and we'll see what happens after that. When I receive a log, I will verify that the cover sheet is correct and then load that data into the program. Then all I have to do is pres one button and the program computes all the information and exports a file ready to be placed in the News - Top Ten and all! So - for at least the next three contests, send your logs to me! I will also be experimenting with the possibility of accepting ASCII logs and if that works you will see something in the next edition of the News.

I have also been given the OK to continue the Anniversary QSO Parties. That means next year we will be looking for members with the number 41 in their number, the year after will be 42, etc. I know I said I would have a sample log in this edition but I ran out of room. If you continue to make regular contact with members, then it will be simple for you to fill out the sample sheet that will be in the next edition - I promise!!!

The last thing to mention was the decision to raise dues. This is generally a very sensitive subject, but if you consider that the last time anything was done with dues, it was to actually lower them! (the 3 for \$25 incentive offer, which has been continued) So if you want a real good deal...pay up for a while! The dues sturcture will change on 01 Feb 2003. 73!!!

PRESIDENT 10-10 International

The Dayton Hamvention was held this year on May 17th, 18th and 19th and 10-10 was there. As usual there was one day of rain. It is traditional that it rains at least one day during this great ham event, and this year was no exception. But the weather had no effect on the attendance which was estimated to be in the range of previous years - 32,000 to 35,000. A good many of the attendees stopped by the 10-10 booth to say "hello" and sign the 10-10 guest log. Over 400 members and guests signed the log. As usual, we handed out approximately 1500 copies of the 10-10 International News. The booth was extremely busy taking dues renewals, selling pins, patches, decals, and other 10-10 items. All monies collected from the sale of 10-10 items will go to the Scholarship Foundation to help fund our five \$1000 Scholarships awarded each year.

Two "firsts" happened at the 10-10 booth this year. A life membership was issued to the youngest 10-10 member in our history. 12 year old Ryan Rose, K3RLR #70749, applied for and was issued a life membership. The other "first" was the application for 10-10 membership by three young sisters, Hillary K8OWS, Holly K8OWT and Laura KC8JUZ. They were issued their 10-10 numbers by Gerry Gross WA6POZ, 10-10 Data Manager, who issued the girls their numbers, in sequence. Hillary was issued #73441, Holly was issued #73442 and Laura was issued #73443. We welcome Ryan our newest life member of Pasadena, MD, and Hillary, Holly and Laura Stienberger of Howell, MI, as 10-10 members.

A forum was held on Saturday afternoon with over 75 in attendance. Gerry Gross, WA6POZ, 10-10 Data Manager made a few remarks and introduced Chuck Imsande W6YLJ, President who gave an update on the happenings of 10-10 during the last year. The forum wound up with Keith Schlottman KR7RK, giving one of his remarkable and interesting presentations on 10-10. A question and answer session provided the members and non-members a chance to ask questions which were answered by the President.

All in all, Dayton was not only a lot of fun, but was another good exposure for 10-10. If you have never been to the Dayton Hamvention, consider going next year. It is an experience you will never forget!

The annual 10-10 Board of Directors Meeting was held in San Antonio, TX on Saturday, June 1, 2002. All officers and directors were in attendance. A number of significant items were on the agenda. A few of the more important items considered and acted upon by the Board were:

· Reports of all Officers and Committees were accepted as

presented.

- \cdot The approval for the use of e-QSL cards for all 10-10 awards that require QSL confirmation.
- · Consideration of a Mobile Contest each year was discussed and approved by the Board. The Mobile QSO Party will be a one-day, 24-hour contest, same as the October 10-10 day Sprint, and will most likely be held in March of each year. This is another effort by 10-10 to keep the 10-meter band fully occupied. Full details and rules are published elsewhere in this edition of the NEWS.
- · Editor Steve Rasmussen, NOWY, presented the Board with a new computer program designed to score all of the 10-10 QSO Parties. Steve also volunteered to score the rest of the QSO Parties for the balance of this year 2002 which was readily accepted by the Board.

The committee studying the use of a master data base program for the record keeping of all 10-10 awards met on the day before the Board Meeting and received a presentation from the two bidders interested in providing a program for 10-10 award keeping. After a full afternoon of discussion the committee concluded that there were too many unanswered questions to make a recommendation on either program at this time. The committee made a recommendation to the Board that the present committee is disbanded and in the future, a new committee be formed to further study the requirements for such a program. The Board agreed with the committee recommendation.

After much discussion regarding overall costs for conducting the business of 10-10, and facing the fact that increases in postage and printing have been absorbed in the past few years, along with the scheduled increase in postage and possible printing cost in the immediate future, the Board voted to increase the yearly dues. The new dues will be \$15.00 per year (3 years for \$40.00) for US members, and \$18.00 per year (3 years for \$50.00) for DX members. Life Membership was also revised to \$500.00 for Regular members, and \$150.00 for Senior Life for US members. DX Life membership was revised to \$600.00 for Regular members, and \$200.00 for Senior Life membership. A payment plan will be developed and published in the NEWS. This is the first increase in 10-10 dues for many years and will help to cover the increase in cost of printing and mailing the NEWS. As we all know the cost of postage has increased several times during the past few years. The effective date for the new membership dues structure was set for February 1, 2003, allowing adequate time for all current members to avail themselves of our old membership rates.

The Planning Committee reviewed the three proposals submitted for the 2003 convention. After a review of the advantages and disadvantages of each site, the committee recommended to the Board that the San Antonio, TX bid be accepted and the Board agreed. The dates for the 2003 convention will be June 26, 27 and 28, 2003. Watch for more information on the Convention details from the Convention Committee headed by Ray Dobson, N5DAS. Pre-registration

will begin on January 1, 2003. Mark your calendars now and reserve this date for the 10-10 Convention in the year 2003 in San Antonio, TX.

A Club Life Membership was awarded to the Radio Society of Great Britain. The special 10-10 number assigned to the RSGB was 73737. A certificate was presented to Director Mike Crawshaw, G4BLH #18466, who will present the certificate to the RSGB. This is the second Club Life Membership awarded by 10-10, the other being awarded to the ARRL station W1AW.

The resignation of our Contest Manager, Don Ward, WORTV, for personal reasons, and the resignation of our 1000+BARS Manager, Allen Mattis, N5AFV, for medical reasons were reluctantly accepted by the Board. Both Don and Allen have served 10-10 well by devoting many, many hours of their time to accomplish their volunteer jobs. A big "Thank You" to both of these dedicated members for their years of service to 10-10

The Board said "Goodbye" to the current Secretary, Dave Prichard K5OVO, and three Directors, Bob Peschska K7QXG, Rex Holford K0NO, and Brad Kimble K0DBK. They all have decided not to run for re-election, and their terms will expire on December 31, 2002. These folks have served 10-10 well and have worked hard to keep 10-10 one of the best ham organizations in the world. They will be missed.

On Sunday, June 2nd the annual 10-10 Hill Country Picnic in Texas, was held at the home of Jack Moore K5CC. As usual all 10-10 members are invited to attend. Forty-seven attended this get together including several members of the Board of Directors and other 10-10 Officials. Ten meters was not good to the group, but the food and sociability was outstanding. All participated in a parking lot net including several out of town check-ins. In addition to the Picnic, a group of 35 attended a Mexican restaurant in San Antonio for dinner, an evening of not only good food, but a lot of great eye-ball contacts. Our thanks to Jack and his lovely XYL Barbara for a good time both Saturday night, and at the Sunday annual Hill Country Picnic.

By the time you read this, or shortly there after, all current (dues paid up) members will be receiving their 2002 election ballot. You will be voting for a President and four Directors. The Vice President and Secretary positions are also up for election, but both are un-opposed. It is important that all current members vote. Bios of each candidate are in this issue of the NEWS. Consider the qualifications of each candidate and vote for the nominee that you believe will contribute the most to the organization.

A big "Thank You" goes to the Nominating Committee under the chairmanship of Gini Segedi N7DB, and her committee of Doris May KJ7RF, Dick Corlew NC6V, Ken Harmon K1IEQ, and Ed Bryant KM5FF for a job well done.

I have assigned the task of reviewing the 10-10 Web Site to Director Mike Crawshaw, G4BLH. Mike will be reviewing the entire web site to determine any changes that are necessary to update the web. Any changes that you think should be made, or any additions that you would like to see on the web please

contact Mike. His e-mail address is on page 2 of the NEWS. Mike will be responsible for coordinating all changes with our Internet Manager, LB Cebik W4RNL who will implement the changes.

Remember the Anniversary QSO party which is a year long event celebrating the 40th birthday of 10-10. Make as many contacts as possible with 10-10 members with the number "40" anywhere in their 10-10 number. For details see the rules in the January issue of the NEWS.

WILL YOU SEND A LETTER TO YOUR CONGRESSMAN?

A bill introduced into Congress needs to be heard and acted on. This is important for all hams. You can help by sending a letter to your Representative. An example of a letter is shown below.

Washington, DC 20515
Dear Representative

I urge you to co-sponsor H.R. 4720, the "Amateur Radio Emergency Communications Consistency Act" sponsored by Rep. Steve Israel. The bill would alleviate a problem facing many federally licensed Amateur Radio operators living within development communities who are subject to unreasonable restrictions or outright prohibitions regarding the installation of external antennas

Under current law, the FCC applies a policy that instructs states and localities that they must reasonability accommodate Amateur Radio antennas. The policy, however, fails to address situations affecting private land-use groups. Rep. Israel's bill would ensure consistent application of these regulations.

This legislation seeks to insure that Amateur Radio operators are available for emergency communications in all sections of the country, regardless of whether they live in a development, such as a retirement community, or townhouse subdivision. Restrictions against antennas render Amateur Radio operators unable to utilize their licenses, which in turn may ultimately hinder their emergency communications role during times of disaster or national crisis.

Amateur radio provides a vital public safety communications service to the public at no cost to taxpayers. I hope you will join Rep. Israel in co-sponsoring his bill.

I look forward to hearing from you as you consider this important legislation.



Coincidentally, this acceptance of this scoring system comes at the same time of the resignation of Don Ward, W0RTV, as our Contest Chairman.



Information To Help you decide On the Best Antenna For <u>You</u>

In each issue of the News, we shall try to clarify a significant cluster of ideas used in antenna work. Our object is to help you make the best decisions about the antennas you buy or build without imposing our own prejudices on you. The more you understand, the better your choices will be.


No. 36: 4- and 5-Element OWA Yagis

The OWA (Optimized Wide-band Antenna) design for Yagis means different things to different designers. For some, it means simply a low SWR across a passband (like 28-29 MHz), regardless of the impedance. To others, it means a low 50-O SWR across the passband. Since many 10-meter users are more comfortable with a direct coax feed (with a choke balun for protection from common-mode currents down the line), let's take the latter approach.

Last time, we looked at a 6-element 24' OWA using fairly thin elements. This time, let's look at some shorter designs using elements with larger diameters. In fact, in this episode and the next, we shall look at a total of 4 OWA design ranging from 13' to 36' long, all with the same element structure.

Fig. 1 shows the element structure that all of the beam designs will use. The 4' center section is 3/5" tubing, with a short 1.5' (plus 3" for overlap) section of 5/8" tubing following. The "tips" are 1/2" tubing. All this can be obtained from sources that advertise in QST or CQ. In the element length tables, be sure to add 3" to the 1/2" tubing for overlap.

For higher wind loads, you can let the 5/8" tubing go all the way through the 3/4" element. For lesser winds, the 3" overlap will do well.



Of course, the driven element must be open at the center for the feedline connection. You can use a fiberglass tube across the gap to keep the element aligned and strengthen it.

A 4-Element OWA

OWA design require one additional element to achieve the 50-O feedpoint impedance compared to beams with feedpoint impedances in the 25-O range. Shorter OWAs must also be a bit longer than their 3-element low-Z counterparts for the same performance. While a 3-element Yagi with about 8 dBi free space gain needs a 12' boom, our OWA will need a 13.5' boom.

Fig. 2 Outline of the 4-Element OWA




Fig. 2 provides the outline of the 4-element version, with the spacing between elements shown. The following table lists the element spacing from the reflector, the tip length, and the total element length from tip-to-tip for reference, all in feet.

Element	Space from	Tip Length	Total
	Reflector	Length	Length
Reflector	0	5.34'	17.68'
Driver	5.12'	5.10'	17.20'
Director 1	6.87'	4.57'	16.14'
Director 2	13.00'	4.10'	15.20'

The elements are designed to be insulated from the boom. If you change materials or element structures, an entire redesign will be needed. Do not be casual in your construction of Yagi designs you find in handbooks. They simply will not perform up to the original design if you alter the element diameters or the tapering schedule.

The 4-element OWA provides an average gain of over 8 dBi (free-space). The front-to-back ratio is above 20 dB across the 28-29 MHz span. The 50-O SWR is exceptionally low. Hence, the beam is a fit candidate for reproduction in the home workshop.

A 5-Element OWA

If we add about 6' to the boom and one more element (respacing all of the others), we can add about 1 dB to the overall gain of the OWA Yagi. A 19' boom will hold the elements, which use the same construction as the 4-element version.

Fig. 3 Outline of the 5-Element OWA





Fig. 3 gives us the outline of the 5-element OWA, as well as the inter-element spacing. The following table provides the structural details.

Element	Space from	Tip Length	Total
	Reflector	Length	Length
Reflector	0	5.52'	18.04'
Driver	5.30'	5.16'	17.32'
Director 1	6.70'	4.70'	16.40'
Director 2	11.10'	4.65'	15.30'

For the extra element and boom length, we get a gain that ranges from 9.1 to 9.4 dBi (free space) across the 28-29 MHz span. The front-to-back ratio is close to or above 20 dB over that same frequency range. The SWR is quite smooth across this range.

Once more, the design is for elements insulated from the boom. There are many systems for mounting elements to the boom. I tend to prefer 6" by 12" plates of polycarbonate (a generic name for the material sold as Lexan), which has good sun (UV) resistance, good RF properties, and is very strong. 1/4" thick material works well at 10 meters. It is much more

durable and maintenance free than plywood (which needs periodic varnishing) or more common acrylics (which become brittle after a season or two in the weather). I also use stainless steel hardware throughout, including U-bolts with saddles for the elements and the boom. Other systems also work well, but this one satisfies my experimental needs, meaning that antennas are always being reconstructed into new configurations.



For reference, **Fig. 4** shows the SWR curves for the two antennas from 28 to 29 MHz. These are for direct connection, using only a 1:1 choke or balun to move from the balanced feed element to the unbalanced coax cable. You can purchase a balun, make your own choke from coiled coax, or obtain a choke that uses ferrite beads.

Be sure to weather seal all connections. For coax connectors, a wrapping of 3-M #33 electrical tape starts the job, followed by one of the black butylate sealants. Some folks like to cover the butylate with one more #33 tape coating. Do not stint on weather protecting connections, since water leakage into the feedline can ruin the performance of an otherwise great antenna system.

In a future column, we shall go over some of the good practices to follow in building your own antenna. However, we must first finish our designs for 3/4-5/8-1/2" elements. Next time, we shall look at 6 and 7 element versions of the OWA, both with a flat 50-O Feedpoint impedance, and with an extra dB or so every time we add an element.

I must have my column in to the editor of the 'News' no later than the first of the month of March, June, September, and December. So in order to make the deadline and if you want your chapter information in the current issue, it needs to be in my hands by the 20th of February, May, August and November. Often chapter news or special information is received too late to make the issue on a timely basis. The column for the January issue for instance must be submitted to the editor on the 1st of December. So if your special is to run 1st through 31st December, it should be in my hands prior to 20th August to be in the October issue, as the following issue of the News will not be out until January after your special is over. Chapter information is printed on a space available basis; sometimes not all information received can be printed. The deadline for the next issue of the News is the 20th of August.



There are now **307** countries that have had 10-10 activity as confirmed by QSL cards and Solar Cycle 23 begins to decline as we go into our summer season with a change of propagation and poor skip conditions.

I just sorted my online daily-log into country order and I see that I have talked with sixty-six 10-10 countries over the past six months. Most of the DX activity was in February and March, and the change to summer here in the USA, has brought poor DX conditions to the north but stations towards the south or southwest are still workable.

The Summer 10-10 CW QSO Party in May was like a DX contest as I contacted more DX stations than USA. I logged seventeen countries and only five were 10-10. Tad JA3XOG #10443 was my only Asian contact. My friend Allen ZL3KR #6251 told me he made a hundred contacts. The lack of Europeans was a big disappointment with only a few making it into my log but none were 10-10. Members complained about not being able to work their friends that weekend but that happens when the skip pattern turns south for the summer. USA stations should try backscatter. Do not get mad at the schedule of the four QSO Parties which are evenly spaced out so you get each season of the year to make contacts. The USA winter months will always be the best time to make large numbers of contacts, so just wait.

Here are the details of the four new 10-10 countries worked plus information on North Korea.

FO0/A Austral Islands New Country 304! I worked Leo **K8PYD** #44582 with his call sign FO0FRY in December 2001. Now that this 10-10 country has been confirmed it will be 10-10 country **304** for the record books. I worked him on two bands and swapped numbers with Leo. I received the QSL card April 10th.

VP6GEO South Georgia Island New Country 305! The DXpedition in late Jan 2002, was a nice catch for many. Ralph K0IR #2609 was the only 10-10 member in the group of operators. They only stayed on the island a few days and this was a second stop after putting on South Sandwich the previous week. Due to their location on Sandwich the signal into the USA was very poor and many missed this one. South Sandwich has had 10-10 activity in past years so it was not a new country.

XR0X San Felix New Country 306! Three members were active from San Felix Island in March 2002. I talked with Joe **KO4RR** #46176 for an all time new one and heard Dr. Carlos **NP4IW** #35512 but missed Doug **N6TQS** #72301. This very rare East Pacific island is the last South America country that had never had 10-10 activity. San Felix goes into the record book as worked and the QSL cards from N7CQQ should arrive soon for DXCC credit.

VP6DI Ducie Island New Country 307! Tom Christian VP6TC #73104 used his new 10-10 number very little from Ducie in March. The other 10-10 member was Miralda VP6MW #50434 and I had to remind her what the number was as she had not used it in a long time. This was a first time activation of a new ARRL country, as Ducie is a separate DXCC country about a one day sail from Pitcairn. Both San Felix and Ducie was active at the same time so the band was crowded with people working split frequency when both groups were active on the same band.

Tom Christian is a guest speaker at the HamCom DX luncheon at Arlington, TX. I am at this convention as I finish my DX article and I got to meet Tom. We talked about life on Pitcairn and his two trips to Ducie. The second trip was in March when we worked them but the first try was cancelled due to stormy weather. QSL card requests for VP6DI go to VE3HO in Canada.

P5 North Korea by Ed **P5/4L4FN** #72722 has been approved by the ARRL DXCC for SSB operation. My QSL card arrived mid-May for my ten meter contact in November 2001. Ed has been operating mostly on 15 SSB (21225 listening 21235) with his new AL80A amplifier donated to him. I suspect by November he may go back to ten when conditions improve to the USA. No one has yet submitted a QSL for 10-10 credit. Ed will be in North Korea until June 2003. QSL to Bruce **KK5DO** #65027.

Upcoming DX & New 10-10 Activity:

BQ9P Pratas Is. Located in the South China Sea, it will be put on for the 7th time by a group of operators started June 4-12th. The only 10-10 member is Gary **W5FI** #11862, who talked with me and said he would be sure that his 10-10 number gets passed out for this new 10-10 country. There has never been any reported 10-10 activity from Pratas Is. I just worked them on 15M SSB with a very weak signal so good luck on ten. QSL via KU9C.

ZS South Africa and 3DA Swaziland by Frosty **K5LBU** #51322, will be active as ZS6FF from July 5-10th and 3DA0CF from July 11-18th. He returns to S.Africa and will leave August 4th for his return to Houston, TX.

ZC4 Cyprus by Steve **ZC4BS** #52763, reports that during June he will be using a special prefixes from the Sovereign Bases on Cyprus as ZC40BS.

4D70/DZ70, Philippines. Robin DU9RG #36943, advised that from now to December 31, 2002, DU stations are authorized to use the prefixes 4D70 (for individual) and DZ70 (for club call signs).

FO, French Polynesia. Paolo **IK2QPR** #63455, will be active from Bora Bora Island between August 10-14th. QSL: Paolo Fava, via Bertani 8, 46100 Mantova, Italy.

C2 Nauru. The YL mini-DXers, Elizabeth **VE7YL** #50488 (CW), June VK4SJ #63451, Mio JR3MVF and Gwen **VK3DYL** plan to operate next from Nauru (OC-031) from October 1-14th where they hope to use the call sign C21YL. QSL to VK3DYL.

8R Guyana by Len **8R1Z** #72707 was worked on 28440 at 1640Z by stations in the south USA.

JW Svalbard by Tom **LA7VK** #72716 for a quick trip June 4th. He flies his office back to Norway on the 5th.

9M6 East Malaysia. the Hillview Gardens resort station **9M6AAC** #70718 in Sabah was activity in June. I just worked them on 18Mhz SSB. QSL to Bob N2OO #12732.

CY9 St. Paul Island. James **VE9DH** #72121 will be one of seven operators are expected to be on the air from June 29th to July 8th. They hope to land on a west side of the island that will help put a better signal into the USA. The west side is much more difficult to land due to high seas.

5A1A Libya. Abubaker #69222 is at college in Germany now. QSL to A. Aassid, Max Strasse 58, Bonn, 53111, Germany with two green stamps if you need a card.

XE1CI Nellie #45888 was hit by a car as she walked in Mexico City. This required a hip replacement plus a pacemaker for her heart. She will be recovering for the next four months at home and is off the air for a while.

Propagation: Solar Cycle 23 is now in a slow decline from the first peak in the spring of 2000 and the second peak in the fall of 2001. Propagation last winter was good through March but the downturn of Cycle 23 has begun this spring. My prediction is for the Solar flux to range from 120-190 during the last half of 2002.

Cycle 23 is now 4.5 years old. The flux continues to stay about 170-180 as this cycle grows older but expect more good propagation this winter for the USA. E layer skip, could produce some interesting summer propagation to the USA with F skip to S.America.

On June 3rd, the Solar flux was 170 the A index 11 and K index 2, which is slightly below the flux numbers three months ago. Fewer Solar flares have been observed the past few months which indicates a drop in the average flux. In January 2003, I expect a Solar flux range of 120-155.

Expect the best conditions on June 1-5, July 2-5 & 29-31, August 25-28 and September 21-24. Stations in the Eastern USA, expect a 20% chance of DX to the East-West path into Europe or Africa. Stations in the Western USA, expect 5% chance of DX into Europe and a 20% chance into Asia. All of the USA will get a 50% chance into S. America in the mid afternoon. Expect a 2% chance of Long Path into Asia or Europe starting at 100Z for central USA. The beacons from 28.175-28.300 will tell you what is open, especially 28.200. Good luck.

in, listen and write down the information given by that station. This will facilitate a more efficient contact list, since you will have all the information needed to confirm the contact. When you are asked to check in, give all of your information, call sign, name, QTH, 10-10 number and VP number if you have one, in one transmission.

During the nets, we highly encourage members to limit any "rag chewing" to a minimum, so other members can make contacts while conditions are up. If you desire a longer contact with a specific station, ask them to QSY at least 10 up or down to keep the net frequency clear. You may need to wait until the net has closed to do this, as some stations may be reluctant to leave the frequency.

We all extend a hearty welcome back to Ed, KC4RIY #58203. Ed is our net controller on Saturday on 28.380, and has had some time off for an operation. He is back with us now, and doing fine. Tom, KA9EKG #70731 has been calling the net for Ed during his absence.

Thanks Tom, for a job well done. Also, Kudo's' to Scotty, WA6TQC #71 for calling the net for Alan, VE4ALN #69217. As most of you know, Alan looses propagation around the end of April for about four to five months, and Scotty volunteered to call the net. Thank you Scotty!!

To apply for any 10-10 Award, <u>proof of paid-up</u> <u>membership</u> <u>is mandatory</u>. A copy of your membership card or address label from the latest copy of the **10-10 International News** must be sent with your application.

An application listing the rules for each award is available from the appropriate Award Manager listed below. Please send your request with a #10 (business size) envelope, self-addressed and stamped with one unit of first class postage, to the Award Manager for the Award you are interested in obtaining. Please no phone calls to Award Managers for an application or list of rules.

BAR AWARDS

A 10-10 Bar represents a legal contact with one hundred (100) 10-10 members. A Bar award may be applied for and awarded for each group of 100 10-10 members that you work. Additional certificates are available for the Bar levels of 1000, 2500, 5000, 7500, 10,000 and every 2500 contacts above.

INTERNATIONAL 500 OF THE WORLD (VP)

When you attain the 500 Bar from the 100-900 bar manager, you automatically become a member of the International 500 Club and will be assigned an honorary VP number to be used in conjunction with your 10-10 number. With the issuance of the number you are eligible to participate in the VP award program. The VP award recognizes those 10-10 members that work other members with VP numbers. A 10-10 member may apply for VP award endorsements when completing 100 contacts with VP members. A VP award may be applied for and

awarded for each group of 100 that you work. Also available to VP members are the VP Worked All States award and the Lucky 13 Certificate. The Lucky 13 award is intended to demonstrate the operator's ability to work the entire 10-meter band. The 10-meter amateur band extends from 28.0 to 29.7 The Lucky 13 award is awarded for completing a legal 10-10 contact with 13 different VP's on 13 different days on 13 different 100 kHz (plus or minus 10 kHz) segments of the band. These contacts must occur between 28.3 MHz and 29.7 MHz. There are 15 possible 100 kHz segments possible within this band section. For purposes of the Lucky 13 award, mobile, portable, or fixed operation may be used. Contacts can be made using any legal mode of operation. QSL conformation is not required.

WORKED ALL CONTINENTS AWARD

The 10-10 Worked All Continents award is issued for successfully working a 10-10 member in each of the six (6) radio continents (Africa, Asia, Europe, North America, Oceana, and South America)

COUNTIES AWARD

10-10 offers an award for working all 3077 U.S. Counties. The basic certificate is issued for the first 100 counties contacted. Endorsement seals are available for each 500 level. A plaque is awarded for working all 3077 10-10 Counties.

COUNTRIES AWARD

The Countries award certificate is awarded for confirmed contacts with 10-10 members in other countries. Applications require confirmations in the form of QSL cards (or non-returnable photocopies). A legal 10-10 contact within the applicant's country may be counted as one contact for this award. A basic

10-10 Countries certificate is awarded for contact with 25 countries. Thereafter, endorsement seals may be applied for in groups of 10 through the 75-country level. Beyond the 75-country level, endorsement seals are awarded in groups of five (5)

CW AWARD

The basic certificate for this award is earned with a minimum of 25 legal contracts with other 10-10 members

MOBILE AWARD

The basic Mobile Contact award is issued for 25 mobile contacts. Each contact must consist of the 10-10 number, call sign, name, QTH (state or country) of both parties and the date. Endorsement seals are available for the 50, 75, and 100 contact levels.

OM/XYL AWARD

Within 10-10's membership there are many husband and wife teams. These are referred to as OM/XYL teams. 10-10 offers the OM/XYL award for contact with as many of these teams as an operator can find. The basic OM/XYL Award is for contact with ten (10) teams.

WORKED ALL STATES AWARD

Make a contact with another 10-10 member in each of the 50 United States and you are eligible for the 10-10 WAS award. QSL Confirmation is required.

WPX (PREFIX) AWARD

The basic certificate is awarded for working 100 different prefixes

GREAT BRITAIN COUNTIES & REGIONS CERTIFICATE

A basic certificate is awarded for completion of a legal 10-meter contact with another 10-10 station in five (5) of the numbered Counties/Regions/Unitary Authorities of Great Britain.

CONTEST RULES AND CALENDAR

10-10 QSO PARTY RULES

6.2 QSO Parties

10-10 QSO Parties are contests and awards are given for high scores in Call Areas, countries, etc., 10-10 likes to thinks of these contests as Parties. These Parties are held for fun and to meet 10-10 members around the world. There are a few basic rules that all participants must follow in order to make the Party fair for everyone and to make the scoring as straightforward as possible for the volunteer scorers. All QSO Party rules are listed below. 10-10 sponsors four (4) QSO Parties and one (1) 24-hour Sprint Party each year. A 10-10 CW QSO Party is held in the Spring and Fall and a 10-10 Phone QSO Party is held in the Winter and Summer each year. The 10-10 Day Sprint is held on October 10th (10/10) each year. All 10-10 QSO Parties are 48 hours long except for the Sprint Party, which is 24 hours in length.

6.2.1 Who Can Participate?

10-10 QSO Parties are open to all amateurs with operating privileges on the 10-meter band. 10-10 members may use any contacts made for 10-10 awards. Non 10-10 members may use contacts to qualify for 10-10 membership or may chose to just give their call to 10-10 members.

6.2.2 Entry Classifications

You may enter each QSO Party in ONE of the following categories: Individual, Club or QRP. The Individual category includes single station operators and can also include OM/XYL or families using one shared station with individual call signs and 10-10 numbers. The QRP category is for stations with output power of 5 watts for CW, 10 watts PEP for SSB or 10 watts for AM/FM. Stations operating in the Club category must be a legitimate 10-10 Club with a registered 10-10 number, a government issued call sign and a

membership of at least 5 amateurs. All Club members operating the Club station during a Party must be paid members of 10-10. A list of all operators in this category must accompany the submitted logs. Multi-transmitters (2 or more transmitters operating simultaneously, sharing one call sign) are NOT accepted in any QSO Party.

6.2.3 Score Assignment

Under certain circumstances it may be possible to assign your QSO Party score to your local 10-10 chapter. Only a paid 10-10 member belonging to a particular chapter as a local member may make chapter assignments of scores. Local members are defined as those members that can work the chapter net via ground wave. If in doubt regarding your qualifications to assign your score to a 10-10 Chapter, either do not claim Chapter score assignment or contact the Contest Manager for confirmation. The 10-10 Sprint Day Party does NOT allow Chapter assignment of scores.

6.2.4 Logging Contacts

During a QSO Party or 10-10 Day Sprint, log your contacts with the following information: date/time in UTC, call sign, name, QTH (state or country), 10-10 number, and points claimed. A sample log sheet is included on the 10-10 web site to aid you in setting up a log. All logs must be in UTC. If you log by hand, the above format will work well. If you log by computer, you may need to add columns for the 10-10 number, etc. Both hand logs and computer logs are acceptable for all 10-10 QSO Parties and the 10-10 Day Sprint. QSO Party logs may be submitted for ONLY one (1) category. For example, a single log CAN NOT be submitted in both the QRP and Club categories. In 10-10 Parties individuals compete against individuals, QRP stations against QRP stations, and Clubs against Clubs. QSO Party and 10-10 Day Sprint logs are accepted from paid 10-10 members ONLY.

6.2.5 Call sign/10-10# Dupe Sheet

A Dupe Sheet is required for all QSO Party and 10-10 Day Sprint log submittals based upon the following criteria. A Dupe Sheet is required if more than 50 contacts are made. Either hand generated or computers Dupe Sheets are acceptable. All submitted Dupe information should be in an alphanumeric sequence. Duping may be accomplished by use of the 100 square grid method using either 10-10 Number or call sign information. Example Dupe Sheets are included on the 10-10 web site. Some Contester's keep the Dupe Sheet current as they work each station, others bring it up to date during lull periods, and still others fill it out after the contest is over. Use whichever way suits your method of operation, but a call sign or 10-10 number Dupe Sheet MUST be provided with your QSO Party or 10-10 Sprint Party submittal is over 50 contacts are claimed.

6.2.6 Cover Sheet

QSO Party logs must be submitted using a 10-10 Cover Sheet. 10-10 Cover Sheets are published on page 32 of each issue of the 10-10 International NEWS. A sample Cover Sheet is also included in this Brochure or you can find a Cover Sheet on the 10-10's web site. An approved Cover Sheet You MUST be used one of these approved Cover Sheets when submitting your QSO Party or 10-10 Sprint results. Whatever Cover Sheet is used, make sure it must be is filled out completely - name, call sign, 10-10 number, current mailing address, date of contest entered, etc.

6.2.7 Contest Submittal

The contest submittal package for any 10-10 QSO Party (CW or Phone) as well as the 10-10 Day Sprint, must include all of the following four (4) items: 1. Cover Sheet with all blanks filled in 2. Proof of membership such as a copy of your 10-10 dues card or mailing label from your latest copy of the 10-10 NEWS showing that your 10-10 dues are current as of the date of the QSO Party entered 3. Log in UTC format; hand or computer generated is acceptable 4. Call sign dupe sheet completed (if over 50 contacts are claimed) using 10-10 numbers or using call signs. - all contest submittals must have a Call Sign or 10-10 Number Dupe Sheet if over 50 contacts made. No dupe sheet is required if less than 50 contacts.

6.2.8 Certificates

A certificate will be awarded to the top scorer in each country and each US call area for each CW and Phone QSO Party, and for the 10-10 Sprint event. A country is

Certificates will also be awarded to the Top 10 finishers in the world and to the first place finishers in the Club, QRP, and chapter categories. In the event of a tie, the tiebreaker will be based on the greatest number of contacts made. All final scores for CW and Phone QSO Parties, and for the 10-10 Sprint event, for both DX and US call areas, will be published in the 10-10 NEWS for each scoring category along with aggregate chapter scores.

6.2.9 Quiet Zone

During 10-10 QSO Parties, 10-10 members are requested to have the courtesy to observe a Quiet Zone between the frequencies of 28.490 and 28.510 MHZ for non 10-10 Party uses. Remember that the 10-10 organization promotes courtesy on the 10-meter band.

Please leave the above frequencies open for non 10-10 members to use.

6.2.10 QSO Party Rules

The following eleven (11) rules apply to ALL scheduled annual QSO CW and Phone Parties and the 10-10 Day Sprint Party sponsored by the 10-10 International Net.

- 1. Phone contest contacts MUST be made within the 10-meter phone band on SSB, AM or FM. CW contest contacts MUST be made within the 10-meter band on CW, RTTY or Digital modes such as PSK31.
 - 2. Repeater or satellite contacts are NOT allowed.
 - 3. All Exchanges MUST include call sign, name, state or country and 10-10 #
 - 4. A station may be counted ONLY once as a contact.
 - 5. All contacts MUST take place during the designated Party hours.
 - 6. All logs MUST be kept in UTC time.
- 7. A call sign or 10-10 number Dupe Sheet IS REQUIRED of all participants that submit 51 or more contacts. (See explanation above Dupe Sheet).
- 8. ONLY a paid member belonging may make chapter assignments of scores to that chapter as a local member (See explanation above). NOTE: Chapter assignment of scores IS NOT allowed for the 10-10 Day Sprint.
- 9. Scoring: Points are earned for contacts with operators that include a valid 10-10 number exchange and for contacts that do not include a 10-10 number exchange.
 - (a) Two (2) points are awarded per contact WITH a 10-10 member.
- (b) One (1) point is awarded per contact WITHOUT a 10-10 number exchange.

 10. Disqualification criteria: Submitting illegible, improper logs or failing to comply with these Rules or their intent WILL result in disqualification. Logging errors
- exceeding 10 percent (%) will result in disqualification.
 - 11. NO logging information will be returned.

6.2.11 Log Postmark Deadline Date

Each 10-10 QSO Party and 10-10 Day Sprint has a log submission Postmark Deadline Date. This date is published in the 10-10 NEWS and on the 10-10's web site. Any logs received with a postmark after the stated Postmark Deadline will be rejected. It is very strongly recommended that all logs be submitted as soon as possible after the close of the Party. It is also suggested that DX stations send their logs via Air Mail to assure timely receipt. Logs are to be mailed to the announced scoring individual(s) and/or chapters. Scorer's names and addresses for each QSO Party and 10-10 Day Sprint are published in the 10-10 NEWS and on the 10-10's web site.

6.2.12 10-10's Worldwide Web Site

Current information about 10-10 and upcoming 10-10 QSO Parties is always available on the 10-10 web site. In addition to the latest QSO Party dates and general information, there is a copy of a Cover Sheet and a sample Dupe Sheet that may be used for submittal of your QSO or 10-10 Day Sprint Party logs. 6.2.13 Additional Information and Clarification

Any additional information or clarifications that you may needed regarding the rules or other information about 10-10 QSO Parties or the 10-10 Day Sprint may be requested through 10-10's Contest Manager.

A date has been selected for the first ever 10-10 International mobile contest.

Web sites that have contest schedules for 2003 were carefully reviewed. There are NO weekends in 2003 that do not have at least 3 or more contests, QSO Parties, or Special Events.

So, Saturday, March 15, 2003 was selected and we will just have to take our lumps.

Herewith are the rules:

- 1. Saturday, March 15th, 2003, 0000Z to 2359Z.
- 2. Participants/Frequency/Mode: Members and non-members of 10-10 International, on 28 MHz only. Any mode.
- 3. Fixed stations contact mobiles; Mobiles contact fixed and other mobiles.
- 4. Mobiles must be a true mobile. Sitting in the driveway and using the base station antenna and/or amplifier is not permitted.
- 5. Exchange: Call, Name, State, 10-10 number (if a member), and county (if applicable).
- 6. Scoring: 1 point for each different station contacted. Multipliers: Multiply the number of stations contacted by the

number of different counties worked. Counties in USA, England, and Canada are approved.

Example: Contact K7QXG and K7PRZ in Oregon (2 contacts). Work them in 6 DIFFERENT counties. Multiply the 2 contacts by the 6 different counties. Score is 12.

Logs. Electronic data and logs are acceptable if the content can be opened and viewed. If not, the log is disqualified. Inquire if you are not sure. Any log in text, RTF, or with a .DOC, .WPD, or PDF extension is acceptable. Excel and Access formats are not acceptable.





PAPERCHASING-SIMPLE COMMON SENSE

by D. Garry Cameron VE7ACM

I have been paperchasing since 1987 and CM of Restoration Project since 1993. The biggest change over the years has been the advent of E-mail Upgrades and List exchanges. Whether you are on E-mail or not, the solutions I offer to some of the problems that crop up still apply.

Scenario #1: You want to Upgrade a Chapter that uses a CM-supplied Upgrade Form (GB Ten, Restoration Project, Twin Cities, et al). You search through your files but you can't find your Upgrade Form.

The WRONG way: Send the CM a great long contact list that he doesn't want, along with a note that you lost your Form.

The RIGHT way: Contact the CM, ask for a new Form, and USE it. Note: Even if you do find your form but have not upgraded in a long time you should still ask for a new Form since it may have changed-seals may have been dropped, new ones added, etc.

Scenario #2: Your computer crashed and you lost

everything. You got a new computer, hard drive, whatever, reinstalled your Upgrade Software, and are ready to start again.

The WRONG way: Enter everything you can find as new and send the whole mess to the CM along with a note about your crash.

The RIGHT way: Contact the CM, find out your total collected points and seals, enter that amount of points and seals, and zero out.

Scenario #3: Someone points out that your list is missing certain information such as a seal or other info needed for worksheets. You have no record of such info.

The WRONG way: Say "I don't know what it is and I don't know how to find out".

The RIGHT way: Contact the CM and find out the info, then add it to your list as appropriate.

These solutions, and those of other problems can be boiled down to three simple words: ASK THE CM. This simple common sense should be glaringly obvious, but I am dismayed at how many people apparently can't see it.

CQ STAR TREK FANS AND CERTIFICATE SEEKERS!

Hamersville, OH - April 13, 2002: The USS JURASSIC is an unusual Star Trek Fan Club in that we have several members who are also Amateur Radio operators. It seemed like a natural thing to merge our interests of Star Trek and Amateur Radio. After all, there is more to Star Trek communications then just Uhura saying "Hailing Frequencies Open" all the time. Amateur Radio seems to be alive and well in the 23rd century. How do we know? Well in the original Star Trek series episode Operation Annihilate! when Uhura can't make contact with the officials on the planet Deneba, Captain Kirk tells her to try GSK783 on subspace frequency 3. No doubt that is the future equivalency of K8SSJ on frequency 28.345. Uhura says it is a private station, which we later find out belongs to the Captain's brother, Sam. And the callsign was probably issued by the FCC (Federation Communications Commission) <grin>.

With that in mind, we decided to apply for a club license for the USS JURASSIC from the present day FCC (Federal Communications Commission) and received KC8LEY on Earthdate 9811.12 (12 November 1998 for those not familiar with Star Trek dates), with our Commanding Officer/president (Carolyn Donner - N8ST) as the trustee of the station. On 5 October 1999 we were granted a vanity call sign of K8SSJ with the SSJ standing for Star Ship JURASSIC. One of our members (Garry Cameron VE7ACM) then applied for the JURASSIC's second Club License, VE7SSJ, which was issued by Industry Canada on Earthdate 9906.22 (22 June 1999).

The USS JURASSIC stays active in Amateur radio in a variety of ways, including working Field Day every year. Issuing a certificate to amateur radio operators who work both USS JURASSIC stations also keeps us busy. The certificate is called the JURASSIC CERTIFICATE and can be earned by anyone with an amateur license. The rules are simple:

- 1. Work both USS JURASSIC stations (K8SSJ and VE7SSJ) on any band and any mode. They do not have to be worked at the same time or on the same band.
- 2. Send QSL cards for both contacts along with a 9x12 SASE (or equivalent IRC's) to one of the addresses below....

- 2. Your valid amateur operator license MUST authorize or qualify you for unsupervised transmitting operations in the ten meter amateur band under your own personal call sign.
- 3. You must make contact with ten members of 10-10 and submit a log listing all contacts, their 10-10 number, call sign, name, date of contact, and QTH (state/province/country). A new member application and contact log is available in Section 1 on page 31 of this publication.
- 4. You must remit dues for one or more years full membership. Fee schedule and payment information can be found in Section 2 on page 31 of this publication.

Primary Membership

Primary membership is available with yearly dues, although there is a special incentive available when you pay for three years at once.

Family Membership

Family membership consists of a primary member and one or more family members who qualify as a 10-10 member (has made the necessary 10 contacts) and who reside at the same location and postal address. Family memberships run concurrently with that of the primary member. Add \$3 for each additional family member for each year. Only the primary member will receive a copy of the 10-10 News.

Life Membership

Life membership is available and may be paid in one lump sum or spread across two or three years. If you wish information on the extended payment plan, please contact the 10-10 Data Manager.

Senior Life Membership

Senior life membership is available to anyone who is currently 65 years of age or older. Extended payment plan is not offered with senior life membership.

Family Life Membership

Family life membership consists of a primary life member and one or more family members who qualify as a 10-10 member (has made the necessary 10 contacts) and who reside at the same location and postal address. Family life memberships run concurrently with that of the primary life member. Family life membership ends when the primary life member becomes an SK. Add \$75 for each additional family life. 
