Much can be said in favor of the museum as I personally was astounded at the amount of equipment and work that has gone into making this museum a reality. Now, on to more pressing business. The convention committee has received three presentations for the 1997 TenTen Convention. After comparing cost, accessibility and other criteria, the Board of Directors has selected Council Bluffs, Iowa as the site for the 1997 convention. 
In the space I have left, I will try and point out one of the directions that I believe necessary for the Organization to undertake. When I became President I promised the membership that I would work toward better service to them. This is what I have tried to do and have been successful in part. We have an excellent Board of Directors, all tuned in to making the organization better for

the membership. They are also in favor of a more business like approach in how we conduct our charge.

In 1991, the first plan was introduced to the BOD for a General Manager to run the affairs of TenTen. The reason given was due to the increase in membership and resulting delays in service to the members due to the many hands through which information must pass before the notification of the member. An Ad Hoc Committee was appointed to study the feasibility of centralization of services. At the 1992 BOD meeting a report was given and the committee was then disbanded with thanks for their efforts. Plans were discussed to replace the then current data provider and mailing operations. This resulted in a call for proposals to take over these services and centralize to some extent. In April. 1993 at a called BOD meeting, two proposals were examined. The BOD approved the hiring of LinGer to manage the data base, sub contract all printing and mailing of the News, management of membership renewals and act as supply manager. It was determined that approximately \$6000 per year would be saved and membership ervices increased in a timely fashion.

This meeting also determined a need for an up to date policy and procedure manual of operation be prepared. With much gratitude to Director L.B. Cebik, this task was accomplished and has been updated through 1996. This manual outlines the workings of the organization, its policies and procedures. This manual, subject to the

bylaws, explains at some length the organizational workings and is available to the membership for a fee.

The general feeling of the BOD at this time was the need for the eventual centralization of all the fiscal and membership associated services. This was concluded to be the proper method to handle TenTen as a business, to increase the service to members, to decrease turn around time for new membership and renewals, and to provide a more efficient up to date data base.

Since that time, a number of problems have been quickly resolved. The News is now delivered by first class mail, US, and air mail to DX countries. Due to the decreased time it takes for renewals to be processed, the data base has been kept more reliable, and we have fewer problems with proper addresses. The key here is that all renewals are serviced in a central location with immediate up dating of the data base. There is no delay between area manager, central data and the member. The old method of first having to go through the area manager, who once a month sent in a report which, depending on when a renewal was received, could cause as much as a 30 day delay in the time the central data manager got the information. This could and did cause delays in the News going out to the member. Although not the fault of the area manager or the data manager, the system held built in delay factors. Once all renewals started going to a central location and not through the area managers, problems decreased. Once again, let me emphasize this was not the fault of the area manager, but of the system. This system still needs some updating by the centralization of all facets of membership associated services. At present we are centrally servicing all new memberships and renewals in the 7th, 8th and zero call areas. The BOD has chosen not to replace the area managers who have given up those areas. For the most part, I believe that this move to be more efficient, time and cost saving, providing a rapid turn around for the member, and an instant updating of the data base. It has been determined that the cost and time of service is reduced by approximately one half with this centralization.

Who better to write a feature station article about than our own President of Ten Ten International Net., Inc. Tom Henderson K4ClH, 33233. Tom was born Dec.13,1936 in Kane Pennsylvania. Move to Woodbury NJ in 1947 and graduated from high school there. He joined the US Navy immediately after and spent four years in the submarine service. His job in the submarine service was Radar and Medical. Tom then enlisted in the Air Force in 1957, and was schooled in electronics and served at Maxwell Air Force Base in Alabama as Ground Communication Repairman. He also maintained equipment at MARS.

Tom became a licensed General Class amateur in May of 1959. At that time He also transferred to the Air Force Institute of Technology at Wright Patterson AFB in Ohio working in the electronics lab and local MARS station. Tom left the Air Force in 1960 to attend Spring Garden institute of Technology to pursue a degree in electronic technology.

He returned to Alabama, and worked at various electronic positions. Employed four years as Chief's Aid for the Montgomery Fire Dept. teaching first aid, and worked with emergency medicine at various hospitals. Tom left the Fire Dept. in 1970, to attend nurses school thanks to a scholarship from the local hospital. Tom married his lovely wife Jean in 1970 also. He became a Registered Nurse in 1974 working in the critical care fields, and as a nursing supervisor until his retirement. In 1980 he received a commission as 1st LT in the Army Nurse Corps. Tom served with the 31st Armored Brigade as Preventive Medicine Officer attached to the Brigade Surgeons Section. He is presently serving with the Alabama National Guard State Surgeons office as Nurse Administrator for the State. His current rank is Major, and will retire Dec. 1996 as LT. Colonel.

Awards Tom has received include the Legion Of Merit, Meritorious Service Medal, three Army Commendation medals, two Achievement Medals and an Alabama Commendation Medal from he Governor. Tom suffered a heart attack in 1986, and had to undergo bypass surgery. This cur-

tailed his career somewhat.


From 1987 to 1990 he was employed with the Tuscaloosa County Sheriffs Dept. as facility Nurse and Reserve Deputy. Also he was employed with the Alabama Health Dept. as aids education coordinator. His final employment was in 1991 was with the University of Alabama Student Health Services. Tom is now a Nurse Consultant in private practice. During Operation Desert Storm he was called to active duty. He did not get to go to the Far East, but his wife did her part there. She is also a RN. Tom stayed home on active duty going around the State assisting in physicals and medical preparedness of the soldiers called to active duty.

JHe was instrumental in developing the Druid City and Broken Hearts chapters. Because of Desert Storm he was forced to QRT these chapters, but once it was over, he re-activated the Broken Hearts chapter dedicated to those with heart problems and the chapter is very active. Tom is a member of ARRL, QCWA, County Hunters, OMISS and YLSSB. He has served Ten Ten as one of the forth call area Mangers, member of the Communications Committee, Nominations committee Chairman, Director and President. Schools attended were Sinclair College in Dayton Ohio, The US Army school of Preventive Medicine, The University of Alabama, and Shelton College.

I am proud to serve on the Board under his leadership.

Maintaining your own chapter home page has at least to advantages. First, you control the format and content, and are not dependent on my error rate. That means you can include information on short term specials and other matters not always apt for the central without the delays inherent in transferring it to me.

But not everyone has access to the Web. So our offer still stands: we can upload both to the Website and to the e-mail list archives chapter information submitted electronically (e-mail or disk) to me. Unfortunately, time constraints do not permit me to type in information from scratch.

10-10 Members On-Line: So far, we have



HE'S PRACTICING FOR THE DAY WHEN HE MIGHT HAVE TO GO MOBILE?

An-Ten-Ten-nas

In each issue of the **News**, we shall try to clarify a significant cluster of ideas used in antenna work. Our



object is to help you make the best decisions about the antenna you buy or build with out imposing our own prejudices on you. The more you understand, the better your choices will be.

No. 12 Multiband vs. 10-Meter Dipoles

If we had unlimited money and space, we could ask the following question sensibly: What is the best 10-meter antenna? The answer might be about 4 stacked long-boom, many-element Yagis from about 70' on up on a rotatable tower on a one-hill island surrounded by ocean. Even that answer might get an argument. However, for most of us, the simple question of what the best 10-meter antenna might be is an exercise in irrelevancy.

A more sensible question is usually this one: which of two alternatives is the better antenna? Each alternative might fit our yard and bank account. However, no general answer is possible. Even if one antenna does outperform another, there are always a number of other factors that affect the final decision. Can I maintain this antenna? What will my neighbors say when they see it? Is it compatible with the rose garden?

With those qualifications in mind, let's compare two antennas on performance alone just because people have asked a certain question: which is better: a multiband wire antenna like a G5RV or a center-fed Zepp on the one hand; or a dipole cut for 10 meters on the other hand? And let's presume you have the room and supports for both antennas to make this a real comparison.

If you like to work all of the HF ham bands and are limited to a single antenna, then the multiband wire is certainly an antenna to consider. An "80-meter" 135' center-fed Zepp, a G5RV 102' dipole, and a "40-meter" 67' center-fed Zepp are all long dipoles, center-fed with parallel transmission lines and differ only in

length. All require an antenna tuner, although some antennas show a low impedance on some bands. The 135' Zepp obviously works better on 80, although all three antennas can show respectable performance from 80-10.

In fact, some folks praise these longer antennas because they show some gain over a 10-meter dipole on 10-10's favorite band. Unfortunately, that kind of claim is like preferring \$10 bills over \$5 dollar bills. I'll take the \$5s if you give me enough more of them than the \$10s. The bill size is not relevant until you know how many of each are at stake.

When comparing any of the longer multiband wires with a 10-meter dipole, the extra gain is not relevant until we answer the question of where it goes and, equally, where it does not go. A lot of variables go into the answer to the "where" question, but we can give a glimpse into the answer with Figures 1, 2, and 3. Each shows the azimuth pattern of 3 antennas (2 dipoles and one multiband antenna) modeled at a height of 35' (a typical amateur backyard installation) over real ground at a 14-degree angle of maximum radiation at 28.5 MHz.

Think of these patterns as looking down on the antenna from overhead. The dipoles are the simple figure-8 double loops. For the loops reaching out to 0 and 180 degrees, the antenna runs up and down the page through the center of the diagram. For the loops reaching maximum at the top and bottom of the diagram, the antenna runs left and right across the page. Each multiband antenna also runs left and right across the page.



Figure 1 shows the 135' Zepp. It has four lobes that exceed the dipole limit by a good bit. However, notice how narrow they are. Notice also the nulls in the pattern. with some careful planning and some good luck in where your yard trees go, you might align the antenna so that one or more of the lobes points right where you find the stations you like to work most. Then again, you might end up aligning the antenna so that nulls point at your second and third favorite spots.



Figure 2 shows the dipoles with a G5RV. Again, there are higher-gain narrow lobes, but aimed more at the 45-degree point on the pattern. The shorter antenna creates fewer lobes. Again, you might use this information to hit one or more of your targets, and possibly miss a few desirable targets.

Figure 3 shows the same data for the 67' Zepp, about the length of a 40-meter dipole. There are only 4 lobes for this shorter antenna, but, of course, 4 nulls as well.

Each of these antennas has its place in some ham's yard, especially for working the lower HF bands (and each antenna will show a different pattern on each band). But is any really significantly better than a dipole on 10 meters? Gain is nice, but those nulls can drive you crazy.

Well, the dipole also has nulls off each side, so it too is limited. However, with an overall length of between 16' and 16.5' (depending on

the element diameter), it is not too difficult to put up a rotatable dipole. You can hand -rotate the



antenna mast or use a TV rotator. Then the nulls disappear. More correctly, they go where you put them, as you broadside the antenna to the desired signal. Hence, you only have to rotate a dipole 90 degrees to get full 360-degree coverage.

A stack of TV masting with a house clamp only roughly tight or guys in guy rings would permit you to hand turn the mast. You can attach a short level to the mast to make turning easier. Except in odd late afternoon shorter skip conditions, where signals seem to come from every direction, you will likely only have to change the antenna's orientation every few hours.

Am I "pushing" the rotatable dipole? Not really. Part of my point is that gain is not everything, especially if it does not point anywhere useful. Part of my point is that pointing is more simply done on 10 meters than many people believe, especially if they only look at monster 20-meter beams. Part of my point is that a multiband wire antenna is a very useful antenna . for working all the bands. And part of my point is that, with a little ingenuity, a 10-meter dipole can do a lot of useful work for us without being unduly noticeable or expensive. Even if you already have that long wire, you might also consider adding a rotatable dipole to the antenna "farm." Now, if it is simple enough, you might even take it apart, toss it in the truck or trunk, and go portable with it-and put it back up when you get home.

the membership submit award applications that do no conform with the rules. Yes, rules as outlined for each award and available from the managers in return for an SASE.



TenX DX News

This article is dedicated to the first person that achieved the coveted 1010 DXCC. This modest lady was honored to be on the cover of the 1010 News after she confirmed 100 countries, a major 1010 accomplishment! We met on the radio in 1979 when I started to be active in 1010. Back then Cycle 21 was giving us excellent conditions, we sometimes talked daily before I would go to work and she always had that easy going nature. When not working on her farm she was on the radio paper chasing and DXing so she had a head start on many. WD9CXQ worked many people during the 70's & 80's, and took on the job of 9th Area Manager during her spare time. My only time to meet Bernice in person was at Dayton in 1983 while she sat next to the Parrot in the O'Hare cafeteria. At the time, she immediately reminded me of my mother but I never told her of the resemblance's. Years passed and she began to have less time to spend on the radio, her health problems increased and she gave up her Manager job in 1991. I remember asking her why she never increased her country count and she said other things were now more important. Bernice's health got more serious and finally circummed to cancer on July 21, 1996 when Bernice Tielemann, N9CDO #20025 became a silent key. Hugh, WA4QZU, said: "Bernice was the premier paper chaser of her era. Her passing causes me to recall some of the 'good old days'. May she always have good propagation. Tempus doth Fugit." RIP.

Skip for the Summer QSO Party was the best in years! As I said in my last DX article, the most interesting thing since June has been the return of short stateside skip on Ten. A weak DX opening during the summer QSO Party started about 2100 Z for us in the middle of the US. Many QSO Party participants did not notice the very weak Europe stations as it was much easier to work the stronger stateside stations that had S9 signals. The DX opening lasted less than an hour. This type of opening has only occurred when the solar flux has been above 80 and that is exactly what

caused improved conditions that weekend.

Thanks to the people that sent me their QSO Party log so I could do a propagation study. At the start, there was very weak 1-2 hop skip in the mid US that lasted until about 300 Z. Stateside, the band opened 13-1400 Z with the East coast having skip into the mid US and the mid South into the Great Lakes. Signals were over S9 but varied up and down in strength. This continues until about 2000 Z when it closed for two hours and then reopened for three more hours with weak signals. Sunday this pattern repeated but the band stayed open from 1300 to 2400 Z.

The new callsign changes now being allowed by the FCC caused some confusion during the recent QSO party. Members with changed callsigns did not match with the 10-10 database! One lady got so upset, she went back to using her old call when asked about the 10-10 difference! Watch September 23 for 'gate 2' when those of us in the extra class group get our chance to upgrade!

Now a Canadian callsign story: From Paul VE1DX #42051 (ex VE1UK); "Hi Mike, first, Andy VE9DX #40999 (ex. VE1DX) is alive and well. He is still located in St. John, NB Several years ago Industry Canada broke the maritime provinces into 3 call areas. NB became VE9, PE1 became VY2 and NS retained VE1. No amateur in NB or PEI was forced to give up their old VE1 call, they had the option to keep their original call or get a new one reflecting the province they lived in. Most went with new calls, but there are still VE1s in NB and PEI, and many will keep them. Andy had both VE9DX and VE1DX, he used VE1DX as a packet radio repeater call for a while. Last vear he simply got tired of paying for two licenses (in Canada we have to pay \$24 a year for each call we have.) He let VE1DX go, retained VE9DX and I got VE1DX. I do not know if VE1UK has been reissued. I've not heard anyone using it. So, as far as 10-10 goes, my number is 42051. I suppose Andy still has the original number. He is no longer active on HF or VHF, but retains E9DX in case he returns to the air waves. '

Last time I talked about long path conditions on Ten and quickly found out that it is NOT so rare, conditions in his article "10-Meter Long Path During Solar Cycles 21 & 22". Propagation: Solar flux will range from 68-84 in the Fall/Winter of 1996, as I write this, the Solar flux is 69, the A index 8 and K index 1, about the same as last quarter but more absorption of signals. The flux never got below 65 during the summer, but dips to 67, high A indexes greater than 15 and the K index greater than 4, will occur 10% of the time. For stations in the US, expect a 12% chance of DX propagation to be East-West paths into Europe and in S. America, expect a 15% chance of DX skip into Europe and Asia. Expect light Sporadic E Layer conditions during the fall to be 2-4 hop skip that will travel 500 to 2000 miles with fading. Remember to listen for the beacons (28.2-28.3) to check conditions.


Virginia City Radio Museum



Why a Contest?


Radio Contesting is not a new aspect of our hobby. It dates back to the late 30's. Organizations such as the ARRL initiated these Contests for numerous reasons. I guess probably the more legitimate being a test of our equipment preparedness and traffic handling skills of ourselves. In any case, our hobby has been proven to be one of great value to communications time and time again during emergency situations. It is quite important that emergency traffic be handled with no errors. Contesting helps us to hone these skills. The rules for contests are quite important and it is imperative that they be followed to the letter.

Other perks that one may enjoy as a contest participant are of value too. Getting that last state for WAS or the 100th Country for DXCC has happened many times over during a contest. In the case of 10-X QSO Parties, it is a terrific way to collect new numbers for those BAR Awards, add Counties, etc. No matter what your reasons may be to enter a Contest of any kind, keep in mind that contesting is not everybody's cup of tea! We should be courteous and observe the "quiet zones" and be aware of those around us who do not care to be involved. Of importance also is to follow the rules of the particular contest.

The rules from contest to contest are not uniform and may differ quite a bit. Therefore, it is important that you familiarize yourself with the rules if you expect to run a smooth contest and get your results published, or moreover, be eligible for an Award! As Contest Manager for 10-10, I have viewed numerous infractions of the rules during the August 96 Phone QSO Party. I will go over the more blatant ones. I received 43 logs at my QTH for scoring. Contest logs for 10-10 Parties always go to a scoring Chapter. I realize that there was some misinformation printed in another Radio Journal, so I can account somewhat for that. The Ten Ten NEWS is our BIBLE. Regardless of what you may read in other publications, or hear over the air, we always go by what is printed in our NEWS. In any case, this is a very small infraction compared to what I witnessed in the logs that I did receive. Of the 43, only 2 of them were complete and by the rules! Amazing isn't it! The rules are quite clear. What is it that is not being understood? If you are new to contesting, and do not understand a rule or terminology, Ask Someone. Logs were received with no proof of paid up membership. No dupe sheets, No cover sheets, No dates or times, and generally sloppy illegible logs. Some even tore sheets out of thier logbooks and expected the scorers to pick out the Contest QSO's!

Were you or your Chapter to score a Contest, would you want to receive logs such as these? Do you think it is fair to the guys (majority) who do abide by the rules? I don't believe so! We gave those folks a break this time by returning their logs to them at 10-10's expense for proper re-submittal, but this is the last time. In the future, any non-compliance of the rules will result in disqualification from that contest without notification. Those logs will be used as "check logs" and the call signs printed as such in the results.

My advice is to go over the rules. If you do not have a copy of them or need log sheets, dupe sheets and such send a SASE to me. I'll get you what you need. You then can make copies or future use. To maintain uniformity and ease the burden on the Scoring Chapter, I suggest that you make a copy of the last page of the NEWS. This contains the cover sheet along with the mailing label which is proof of your paid up dues. In the case of DX whose mailing label is on the protective envelope, make a copy of your membership card. Lets try to make these contests fun, fair, and equitable for all.

The Chapters Speak....

In 1995, the Operations Committee of the Board of Directors began a survey of all the known 10-10 chapters to find out what Certificate Mangers (CM) and Chapter Heads (CH) believed about their role in 10-10 and about chapter operations. Over 70% of the forms mailed world wide were completed and mailed back, an unusually high return rate for surveys. Here is a sampling of the results.

We asked CMs and CHs about the role of the chapter in 10-10. Overwhelmingly, they agreed that the chapter's chief role is to encourage local 10 meter activity, especially during sunspot minimums. Almost as strongly, they believe that the chapter's basic way of promoting activity is its weekly net, but that second to the weekly net, the chief way of promoting activity is its certificate program. However, they strongly concurred that on-the-air fellowship is more important than paper chasing. Chapter officials clearly believe in their work, as they agreed that the Chapter's chief role is to promote 10-meter activity nationally and internationally, and they also found good agreement in the proposition that the Chapter is as important as the international organization.

On the subject of recruiting local members for chapters, chapter officials were (taken as a group) somewhat less unanimous, although most indicated that they recruit local members. They

agreed strongly that chapters encourage all local hams to join both 10-10 and the chapter and only slightly less strongly that their Chapters encourage local Novice and Tech+ operators to join 10-10 and the Chapter. Slightly less agreement was shown for the idea that chapters encourage local participation in 10-10 contests as a chapter activity. Many chapters rely for members on its certificate program, while only about half indicated that hold regular face-to-face get-togethers or use other special activities to hold the interest of members.

The survey respondents strongly agreed that the key requirement for joining a chapter is that the member must have a 10-10 number. To a lesser degree, they tended to hold that a chapter member must be a paid up member of 10-10 and must apply for a certificate or a numbers-only substitute. However, respondents tended not to make regular check-ins or dues payment a requirement of chapter membership.

Although most survey replies indicated that a chapter should have an active Chapter Head to guide its efforts, and that the Chapter Head and the Certificate Manager should not be the same person, the majority of responses believed that the Certificate Manager is the most knowledgeable and important officer in the Chapter. Net meeting obligations are very important to the chapters, although replies were even divided on whether nets were primarily for locals or for distant stations. Almost all agreed that quarterly chapter reporting is an appropriate obligation to 10-10.

How a chapter handles its certificates and awards is an area of disagreement or uncertainty. While a moderate majority agreed that a chapter should have only one basic certificate per program and issue "numbers only" to qualifying applicants, the chapters were split on questions like whether a chapter should have only one certificate program and whether upgrades should be issued on the air. Most did agree, however, that basic awards (numbers and points) should not be issued on the air.

On the question of certificate quality, there was little disagreement among respondents. They strongly agreed that chapter certificates should be distinctive to the chapter or its theme and that they should bring credit to 10-10 as a whole. Almost as strongly, they agreed that

chapter certificates should be on high quality paper stock and should be professionally printed. CMs and Chs were equally in agreement that chapter certificates should be priced to just recover costs of the program and not to cover the cost of all chapter activities.

There was less unity on questions of certificate qualifications. Respondents agreed moderately both that basic awards and upgrades should be contact-based and that they should be point-based, indicating that to at least some degree, these views are compatible. There was equally moderate agreement that upgrade programs should be complex enough to be interesting to participants, but they do not need many named levels to hold interest. a slight majority favored the idea that upgrade programs should never require more than an SASE, while an equally slight majority believed that upgrade programs should not necessarily lead to new certificate programs.

Equally lower in unity were responses related to upgrade applications. About the same level of modest agreement was registered for three propositions relating to rigorous application procedures: that upgrade applications should require the submission of very complete records; that upgrades should be either on Chapter forms or on computer programs; and that upgrades are checked item-by-item for accuracy and legitimacy. However, in a contrary vein, an equal level of support was given to the proposition that upgrades are mostly a matter of trust in the applicant. A majority of survey replies indicated that club stations are a valuable asset to paper chasing, and that OMs and YLs may submit upgrades as a team only if both parties have worked all claimed members. However, opinions were split as to whether teams should be restricted to OM-XYL pairs or permit other family combinations.

While most CMs and CHs agreed that specials are important because they renew interest in the Chapter's certificate program, they also allowed to the same moderate degree that specials should be held no more than once per year by each Chapter, perhaps because there are too many specials each month for a paper chaser to keep up with. Responses were split or neutral on questions as to whether specials should be avail-

able on lists to save on-the-air time and whether paper chasers should use only certificate numbers and points received rethe air. However, there was moderate agreement on the idea that a single contact should qualify anyone to use all entries on the other party's list of certificates and points. It should be noted that on a number of questions; DX CMs and CHs pointed out that the questions were of ented toward U.S. chapter operations, and the Operations Committee has taken these and other open ended comments very seriously. Indeed, the Committee is especially appreciative of the fact that so may CMs and CHs took the time to carefully read and respond to the questionnaire. As indicated in its report to the Board of directors, the Committee will use these responses as the basis for the creation of chapter guidelines to assist those who contemplate forming new chapters and those who take up new leadership roles in established chapters. Of course, additional comments on any matters related to chapter operations are welcomed by both the Chapter coordinator, Dave McCardell, WD4EWB, and by the Chair of the Operations committee, Ed Redwine, K5ERJ.



The three winners of the \$1000 1996 10-10 International Net Scholarships are announced in the article on page 4.

This is the first time the awards were increased from two scholarships at \$750 each. To date, 10-10 has awarded 16 scholarships at \$750 each and three at \$1000 each, for a total of \$15,000.

The first two scholarship recipients were announced in the Fall 1988 issue of the *News*: Stephanie Ann Dougherty, N8FIT #48844, and Nathan S. Willingham, KA0UFO #48785. Stephanie entered her sophomore year in 1988 as an electrical engineering student at Michigan State University. She was from an all-amateur family. Her father is KN8I; her mother, KD8LI; and a sister, N8ERH. She was first licensed as a Novice (KA8QJQ) in 1982 and attained General Class a year later.

Nathan entered his sophomore year in 1988 at Oral Roberts University, with a major in electrical engineering. He was first licensed as a Novice in 1985, when he was 15. He obtained his General, Advanced and Extra Class in the same year, and elected to keep the same call, KA0UFO. Upon his graduation from high school, he received the U.S. Army National Scholar/Athlete Award

I recently received a note from John R. Miller, WOIKT #37983, who writes: "I wonder if there is a possibility to create a publication of these reflections, and in so doing write the history of 10-10...the publication could be offered at a premium price, with some part or all of it going to the Scholarship Fund...some of the earliest members could share notes of various time frames, such as the first 10 years."

First Annual 10-10 Day Sprint Contest Oct. 10th

The first annual 10-10 Day Sprint Contest will be held on 10-10-96. This 24 hour sprint will begin at 0000Z on 10 October and end at 2400Z on the same day. The rules were published in the July issue of the News, and are basically as follows: All contacts on 10 meters, SSB, CW, AM, FM or RTTY modes may be used. A station may be counted only once regardless of mode. Keep your log in UTC (Zulu time), and exchange call sign name state or country, and 10-10 number, if contact has one. Some stations may request your county. A dupe sheet is required of all participants regardless of the number of contacts. Scoring is two points for contact with a 10-10 member and one point for a contact with a non 10-10 member. Affiliated Chapter assignment scores are NOT applicable for this contest.

Remember, please observe the "Quiet Zone" between the frequencies of 28.490 and 28.51 MHz for the use of non-contesters. 

It goes without saying that your application should be submitted sorted in ascending order according to the award for which you are applying. That's ten-ten number order for bars, VP numbers for VP bars, states for WAS, etc. The manager checks your application for accuracy against a published ten-ten data base. The manager should not have to hunt all over the place checking your info.

The manager is volunteering his time. Why should he have to spend 3 to 4 times the normal amount of times it takes to work an application because of your sloppy, inaccurate, and other wise faulty submittal? Think about this and ask yourself the question. "Would I want to process this application if I were manager?" Or, "Would my (pick one) boss, manager, supervisor, accept this if it were part of my job?"

Folks, help us out. Get a fresh copy of the award rules from the appropriate manager or download it from the 10-10 Web page. FOLLOW ALL THE RULES! Think of the awards manager as a highway construction worker and "Give 'em a break!"


